1. Parliament assembled at Three O'clock.

2. ARRIVAL OF HIS EXCELLENCY THE PRESIDENT

The President and Commander-in-Chief of the Kenya Defence Forces, His Excellency Honourable (Dr.) William Samoei Ruto, CGH, escorted by the Speaker of the Senate and the Speaker of the National Assembly and accompanied by Maces of both Houses, entered the Chamber at Three O'clock.

4. CONVOCATION BY THE SPEAKER OF THE SENATE

The Speaker of the Senate conveyed the following:
