The House resolved on Tuesday, October 04, 2022 as follows-

**Limitation of Debate on the Address by the President**

**THAT**, debate on the Motion on the Address by H.E. the President under Article 132(1)(a) of the Constitution delivered on 29<sup>th</sup> September, 2022 (*Opening of a new Parliament*) shall be limited as follows-

- (i) no more than twenty (20) minutes for the Mover in moving and ten (10) in replying;
- (ii) no more than fifteen (15) minutes for the Designated Party Leaders;
- (iii) no more than ten (10) minutes for any other Member speaking; and
- (iv) at least ten (10) minutes before the expiry of the time, the Mover shall be called upon to reply.
