*[The Speaker (Hon. Moses Wetang'ula) in the Chair]*

### PRAYERS

**Hon. Speaker:** Hon. Members, we do not need any headcount to ascertain quorum. I think we have enough numbers to transact business.

*(Several Members walked into the Chamber)*

Hon. Members, take your seats. Take the nearest available seat. Let me repeat for the umpteenth time, that when the Chair indulges you to take a seat, please, take the nearest available one, so that we do not unduly interrupt business.

Clerk, please, read the Order for today.

### COMMUNICATION FROM THE CHAIR

#### PROCEDURE OF ELECTING MEMBERS TO EALA

Hon. Members, as you are aware, pursuant to Rule 15(1) of the East African Legislative Assembly Elections (Election of Members of the Assembly) Rules 2017, the Clerks of the Houses of Parliament, pursuant to Rule 2 of the said Rules, are the presiding officers appointed for the election of Members of EALA today, Thursday, 17<sup>th</sup> November 2022.

The appointment was made vide Gazette Notice No.14039 of 16<sup>th</sup> November 2022, and vide advertisements in the dailies of 16<sup>th</sup> November 2022. Hon. Members, allow me, therefore, to provide guidance to the House on the procedure we shall follow in conducting the election of Members of EALA. The election exercise will be undertaken pursuant to EALA Elections (Election of Members of the Assembly) Rules 2017.

Hon. Members, elections shall be conducted in the National Assembly Chamber and the Senate Chamber, being the venues appointed for this purpose by the presiding officers. In accordance with Rule 2 of the said Rules, the Clerk of the National Assembly and the Clerk of the Senate are the presiding officers while the Speaker of the National Assembly and the Speaker of the Senate are the Returning Officers in the respective Houses. For purposes of the election, a “voter” is defined in Rule 2 as a Member of the National Assembly or a Member of the Senate.

Hon. Members, in respect to the conduct of the election in the National Assembly, Rule 16(1) requires the presiding officer to prepare and give, at the time appointed for election, to each Member one ballot paper. On it shall be written, in alphabetical order, the names of all duly nominated candidates, their gender, age and county. I confirm that the ballot papers have been prepared in the required manner. I noticed that the candidates have also been clustered under the headings of the names of respective categories of nomination, in accordance with Rules 5 and 9.

Hon. Members, voting will be done through roll call where the Clerk will call out the names of Members in the order in which they appear in the Division List. Members who are present, on signing a ballot issuance register, which is available with the presiding officer, will

be issued with one ballot paper. On receiving a ballot paper which has been duly stamped, each Member shall proceed to one of the ballot booths, which are located on either side of the Chair, and secretly record his or her votes by putting a mark in the space provided on the ballot paper. That means recording of a vote against the names of their preferred candidates as clustered.

Hon. Members, Rule 6(1) provides for the allocation ratio for each party, which shall be three times the figure arrived at by multiplying the number of elected Members of that party by such number as the Joint Select Committee shall determine and dividing the result by the total number of elected Members of Parliament.

As such, kindly note that the ballot paper is divided into two clusters, namely, the Kenya Kwanza Alliance and the Azimio la Umoja-One Kenya Coalition Party. The Kenya Kwanza Alliance cluster has 15 candidates while the Azimio la Umoja-One Kenya Coalition Party cluster has 12 candidates.

In respect of the Kenya Kwanza Alliance Coalition cluster, which consists of 15 candidates, a Member will be entitled to vote for not more than five candidates. If you vote for more than five, it will be a spoilt ballot.

*(Hon. John Mbadi consulted loudly)*

The persons to be declared elected in respect of the Kenya Kwanza Alliance cluster shall be the five candidates with the highest number of votes, who must include, at least, two candidates of either gender.

In respect to the Azimio la Umoja-One Kenya Coalition Party cluster which consists of 12 candidates, a Member will be entitled to vote for not more than four candidates. The persons to be declared elected in respect of the Azimio la Umoja One-Kenya Alliance Coalition Party cluster shall be the four candidates with the highest number of votes, who must include, at least, one candidate of either gender.

*(Several Members walked into the Chamber)*

Hon. Members, take the nearest available seats. Please, bear in mind that in accordance with Rule 17(3), a voter can only cast as many votes as the number of the total candidates to be elected, in this case, nine candidates.

It is also important to note that in reckoning with the candidates to be declared elected, Section 4(4) of the East African Legislative Assembly Elections Act, 2011, requires that, at least, one-third of the elected Members shall reflect either gender. Let me also clarify that under Rule 17(4), where a voter casts more votes than the number of candidates that shall be regarded as spoilt.

Rule 17(5) provides:

A ballot paper shall not be regarded as spoilt where the voter casts a number of votes that fall below the number of candidates to be elected.

This means that you can elect to vote for four instead of five, or three instead of four. That will be a valid ballot. However, if you exceed the number, it will be a spoilt ballot.

In accordance with Rule 17(6), a Member who accidentally spoils a ballot paper while voting is in progress is entitled, on surrendering the spoilt ballot paper to the presiding officer, to be issued with another ballot paper in place of the spoilt one.

After marking the ballot paper, and while still in the booth, you are required to fold your ballot paper and proceed to deposit it in the ballot box placed on the Table of the House and resume your seat.

As required by Rule 18(1), once all Members have cast their votes, I will appoint two Members, one from either side of the coalitions, to be the counting agents for the candidates.

In accordance with Rule 18(2), the presiding officer, shall, in the presence of the counting agents count and tally the votes cast.

Pursuant to the provisions of Rule 19, when the votes have been counted and the results of the election ascertained:

1. The presiding officer shall record the results of the tally and report to the House the results of the election together with the number of votes recorded for each candidate under the respective clusters.
2. The Returning Officer of this House shall thereafter send a Message to the Senate communicating the results of the National Assembly, which the Speaker of the Senate as the other Returning Officer will announce to the Senate.
3. The presiding officer of the Senate will likewise record, tally the results, and report the results of the Senate elections to the Senate and the Returning Officer of the Senate will send a Message to the National Assembly communicating the Senate election results.

Upon receipt of the Message from the Senate on the results of the elections in the Senate and the consolidated results from both Houses of Parliament, I will announce the results to the House.

Let me also point out that in the event of a tie between two or more candidates amongst those with the highest votes in any of the clusters, the process will be repeated in both Houses between the respective candidates.

As I conclude, I would like to remind the House that during the entire election exercise, the East African Legislative Assembly Elections (Elections of Members of the Assembly) Rules, 2017 and the National Assembly Standing Orders are applicable and will be enforced by the Speaker as necessary.

Finally, Hon. Members, I wish to draw your attention to Standing Order 91 on decorum during division which require, among others, that Hon. Members shall maintain order in the House. That said, we shall forthwith commence the election and I now direct the presiding officer to proceed.

Before we proceed, there is one more Communication.

#### WITHDRAWAL OF CANDIDATE FROM ELECTION TO EALA

Having explained the process and before the presiding officer commences the voting, I wish to report to the House that on 16<sup>th</sup> November 2022, the offices of the Returning Officers, namely, the two Clerks, received a letter from one Salim Mohammed Busaidi, a candidate under the Kenya Kwanza Alliance Coalition cluster, indicating his withdrawal from the election process. In accordance with Rule 11(1)(2) of the Rules, the deadline for withdrawal of candidacy was on Thursday, 10<sup>th</sup> November 2022 being a day after the nomination day. This may be reminiscent of recent events. In this regard, the presiding officers did not accept his withdrawal. Consequently, his name will continue to appear on the ballot paper notwithstanding his intended withdrawal.

The presiding officer shall ring the bell for 10 minutes and prepare the Chamber for voting. However, before he does that Members at the Bar should come in and take the nearest available seats. Hon. Keynan, where is the nearest available seat?

#### RECOGNITION OF MRS. LUCY WANJOHI, HEAD OF

## INTER-HOUSES AND OVERSEAS DEPARTMENT

Allow me to make a short Communication in recognition of Mrs. Lucy Wanjohi, one of our clerks and the Head of the Inter-houses and Overseas Department in the Directorate of Legislative and Procedural Services, who is retiring from the Parliamentary Service Commission. We wish her well in her future endeavours. I want to add that yours truly here has personally worked with Lucy Wanjohi when we were drafting the 2010 Constitution and she was extremely hardworking, diligent, honest and always on time to do her work.

*(Applause)*

We wish Lucy well. There is a difference between looking young and being young.

*(Laughter)*

Hon. Members, I will allow four Members to say something about Lucy before we go to voting. I will start with Hon. (Dr.) Pukose who was the first to request and then Hon. Keynan.

**Hon. (Dr.) Robert Pukose** (Endebess, UDA): Thank you, Hon. Speaker. Being one of the Members who have worked with Lucy, I want to appreciate her role, especially when we go to the Table Office. I have also worked with her in the House and Procedure Rules Committee. She is a great clerk who has helped us a lot when dealing with Questions, Petitions, or even legal issues. On my own behalf and that of the people of Endebess, I wish her all the best and better life outside there. May God bless you. Thank you so much.

**Hon. Speaker:** Hon. Keynan.

**Hon. Adan Keynan** (Eldas, JP): Thank you, Hon. Speaker. I have known Lucy since her days as a young Company Secretary at the Kenya National Trading Corporation and I remember her in a very unique way. In 1991 as a university student, I walked into her office when she was Company Secretary, during the Kenya African National Union (KANU) regime. At that time, sugar licensing used to be a very important exercise. I explained what I wanted and without asking for too much details, she gave me a certificate to trade in sugar which earned me the first Ksh1 million. Hon. Speaker, that was in 1991. When, again, I found her here in Parliament, she continued her good work. Wherever she has been, she has left an impact.

We appreciate her. It is not the end of the world and I am sure in the next few years she will be very useful in other quarters. If it was my choice and the law permitted, I would have

asked her to stay, but because we must create space for other people, we appreciate and wish you well.

**Hon. Opiyo Wandayi** (Ugunja, ODM): Let me also join my colleagues in wishing Madam Lucy well in her well-deserved retirement. I must also attest to the fact that Ms. Lucy has been one of those impeccable, hardworking and diligent officers that we have ever come across in Parliament. In fact, many a times, when you come across her, you see an officer whose is self-effacing. She does not put on airs as they say. She is an officer who we shall miss most profoundly. We wish her best of luck and encourage those officers that she has left behind to emulate her so that we can carry forward the image and dignity of Parliament.

**The Speaker:** Let us have Hon. Rachel Nyamai.

**Hon. (Dr.) Rachael Nyamai** (Kitui South, JP): Thank you, Hon. Speaker. Let me take this opportunity to congratulate Madam Lucy. For the two terms that I served as the Chairperson of the Departmental Committee on Health and also as the Chairperson of the Departmental Committee on Lands, she was extremely useful. For the few days we have been privileged to sit in your panel, Ms. Lucy has been very useful. Hon. Mutuse can bear me witness that a few weeks ago, she had to make sure that procedure is followed.

So, I congratulate her and as she goes to do her future activities, I would encourage her to continue being active. Hon. Speaker, it is my request that she consults for Parliament. That way, she can be extremely useful even as she goes to her retirement.

## PETITIONS

### COMPENSATION FOR NYANZA-WESTERN KENYA CAUCUS OF INTERNALLY DISPLACED PERSONS

**Hon. (Dr.) James Nyikal** (Seme, ODM): Thank you, Hon. Speaker. I, the undersigned, on behalf of the Nyanza-Western caucus of Internally Displaced Persons, draw the attention of the House to the following:

THAT, in the aftermath of the contested 2007 General Election, the country witnessed unprecedented post-election violence which among other things caused massive displacement of persons from their settlements.

THAT, prior to settling internally displaced persons (IDPs) in camps by the Government, quite a number those who survived the post-election violence atrocities, particularly in hotspots like Naivasha, Eldoret, Kericho, Bahati, Nakuru, and Nairobi fled to their home regions and got hosted by their relatives. They never got compensation and have, therefore, been living under undignified conditions.

THAT, in order to ensure that IDPs revert to normal lives as soon as practicable, the Government rolled out a resettlement programme, including *Operation Rudi Nyumbani* Programme which was intended to facilitate IDPs to go back to their original homes under State protection.

THAT, it is in public knowledge that IDPs, particularly those who were in the designated IDP camps were compensated monetarily with amounts ranging from Ksh400,000 and above in addition to allocation of land for settlement.

THAT, the Nyanza-Western caucus comprises legitimate IDPs who were registered by various humanitarian organisation, including the Kenya Red Cross and the IDP network.

THAT, like other IDPs, the Nyanza-Western caucus of IDPs had legitimate hope that they would also benefit by either being resettled or compensated in order to start their lives all over again.

THAT, to their astonishment, the Nyanza-Western caucus of IDPs were neither resettled nor compensated like other counterparts who were in IDP camps in other parts of the country and have inevitably been unable to recover from the psychosocial and economic damages suffered during and after the post-election violence.

THAT, Government's failure to compensate the Nyanza-Western caucus of IDPs has subjected them to untold pain, suffering disillusionment that has made them to feel forgotten and discriminated against contrary to Article 27 of the Constitution.

THAT, since 2008, representatives of the Nyanza-Western caucus of IDPs have on several occasions forwarded the petitioners' concerns to the Ministry of Interior and Coordination of National Government on various dates, the most recent attempt being on 16<sup>th</sup> September 2019 and 30<sup>th</sup> March 2021. However, the Government has not taken any tangible steps to address their plight.

THAT, any further neglect of the petitioners' plight amounts to serious violation and derogation of their inalienable rights to fair administrative action, particularly with respect to expeditious administrative process.

THAT, the issues in respect of which the Petition is raised are not pending before any court of law, constitutional or any legal body.

Therefore, your humble petitioners pray that the National Assembly, through the Public Petitions Committee, will:

1. Expeditiously interrogate the issues raised in this Petition with a view of determining the circumstances under which for close to 15 years since the occurrence of post-election violence, the petitioners are yet to be settled or compensated.
2. Cause the relevant Government agencies to ensure that the deserving IDPs under the Nyanza-Western Caucus of IDPs are verified and urgently compensated in order to enable them to revert to a dignified life like other counterparts who benefited from Government resettlement or compensation programmes.
3. Make any recommendations deemed fit in addressing the plight of the petitioners.

And your petitioners will forever pray.

Thank you.

**Hon. Speaker:** Thank you, Dr. Nyikal. The Petition is committed to the Public Petitions Committee.

Next Order.

Order! Ordinarily we have 30 minutes to comment. Maybe I should allow that. However, we are limited by time because of voting. Can we proceed to the next Order?

**Hon. Members:** Yes.

**Hon. Speaker:** I know it is a very important Petition.

*(An Hon. Member spoke off record)*

Pardon?

Okay, I will give a few minutes for comments. I will start with Hon. John Mbadi. Each Member will have two minutes. Give Hon. John Mbadi the microphone.

**Hon. John Mbadi** (Nominated, ODM): Thank you, Hon Speaker.

**Hon. Speaker:** Order. Those who want to comment on this Petition can go to intervention because as usual, the screen is full. Go ahead, Hon. John Mbadi.

**Hon. John Mbadi** (Nominated, ODM): Thank you, Hon Speaker for giving me this opportunity to comment on the Petition that has been brought to this House through the Member of Parliament for Seme, Hon. Nyikal. We all remember the unfortunate events of December 2007 to early 2008. That is something that we need to close as a chapter in the history of this country. However, it will not be right to do so when there are Kenyans out there who have been discriminated against and have not received compensation like others. I am not saying that people who got affected in other areas got enough compensation.

We must agree that loss of life can never be compensated. We must also agree that even loss of property cannot be sufficiently compensated. However, there is need for expression of good gesture. It has been done elsewhere. Those who were affected in some parts of the Rift Valley were compensated, but those from Nyanza and Western, and those who were working in Naivasha flower farms and other areas in the Rift Valley and Central Kenya, who were from the western region and were affected by the post-election violence have been forgotten up to today. They have cried for far too long. I hope the Public Petitions Committee that is going to deal with this matter will this time round find closure to this dark chapter in our history as a country, so that we can move on. I am sure Kenya is not prepared to repeat this.

**Hon. Speaker:** Hon. Justice Kemei

**Hon. Justice Kemei** (Sigowet/Soin, UDA): Thank you, Hon Speaker. I wish to comment on the Petition from Hon. Nyikal. As a good neighbour of the people of Nyanza, I witnessed the exodus of the people of Nyanza from other parts of the country back to their homes.

*(Loud consultations)*

**Hon. Speaker:** Order, Hon. Members! The conversations are too loud.

**Hon. Justice Kemei** (Sigowet/Soin, UDA): Hon. Speaker, that was a very sad chapter of our country. We will always pray that elections will be fair in our country and we will pursue peace in the event we are unsatisfied with elections results.

The people of Nyanza deserve to be compensated. Whereas others in other parts of the country have been compensated, I recognise that the people from Nyanza, indeed, have not been compensated. So, I wish to support and call upon the Committee on Public Petitions to judiciously deal with this issue, so that the people of Nyanza get their rights as other people in this country.

**Hon. Speaker:** Hon. Shakeel Shabbir.

**Hon. Shakeel Shabbir** (Kisumu East, Independent): Thank you, Hon Speaker. In the year 2007, we picked up 87 bodies from the post-election violence. We also had a list of all those people who suffered, not only through loss of life, but also through loss of business. The compensation request had been put through and we have been waiting and waiting. It appears like the Government has a different criterion for compensation when it comes to Nyanza, especially Kisumu area. I support the Petition that Kisumu victims of post-election violence of both 2007 and later years be compensated. For those who lost their lives, their families should also be compensated. This has gone on long enough and it is one of those tragedies like the Wagalla Massacre. We had a massacre in Kisumu. We know that 87 people were killed. We must have peace. I know that money cannot buy peace, but money can help the families that are suffering from dire poverty.

**Hon. Fabian Muli** (Kangundo, GDDP): Thank you, Hon. Speaker. Like all human beings, internally displaced people have human rights as articulated in the international human

rights conventions. In this country, we are supposed to have a progressive agenda of solving this issue. It keeps going away and coming back. Recently, we had displaced people from what happened in Kariobangi. When people are displaced, they end up taking land elsewhere like what happened in KBC. They then become squatters and land grabbers. So, it is up to the Government to come up with a progressive agenda on how to solve the issue of IDPs.

**Hon. Speaker:** Hon. Masara.

**Hon. Peter Masara** (Suna West, ODM): Thank you, Hon. Speaker. I support the Petition. My Constituency, Suna West, was really affected during the post-election violence of 2007/2008. Many people were evicted from Kericho, Naivasha, Bomet and Nakuru and they came back to my constituency, Suna West. Many lost their loved ones, property and businesses and some were psychologically affected. The Petition will cure so many things because we have so many orphans and widows who lost their parents, husbands, businesses and properties. These are also Kenyans and they deserve to be treated like any other Kenyan who benefited from Government compensation. If this Petition will sail through, it will help those who were affected to, at least, feel that they are part of this society.

**Hon. Speaker:** Hon. Pukose Robert.

**Hon. (Dr.) Robert Pukose** (Endebess, JP): Nakushukuru Mhe. Spika kwa kunipa fursa hii ili niweze kuongea juu ya jambo la IDPs. Sehemu yetu ya Endebess na Trans Nzoia kwa ujumla, pamoja na sehemu za *western* zilihusika sana kwa mambo ya watu kuhamishwa kutoka makwao na kuwa wakimbizi wa ndani kwa ndani. Hadi sasa, hao watu hawajafidiwa na Serikali. Serikali ilipotenga pesa ya kufidia, pesa hizo zilifidia wakimbizi wa ndani kwa ndani kutoka sehemu zingine isipokuwa wale wa kutoka sehemu za *western* na Trans Nzoia. Mpaka wa leo, wakimbizi wa ndani kwa ndani kutoka *western* na Trans Nzoia wanaendelea kuumia. Mhe. Spika, ninaomba wakati Kamati ya Ardhilhali za Umma itakapokutana, iweze kuita wale Wajumbe wanaotoka sehemu ambazo waathiriwa wanatoka. Ni vyema wakimbizi hao wahusishwe na wasaidiwe na Serikali ili wapate makao na jinsi ya kujisaidia.

What is the status of the disbursement of funds from the Equalisation Fund for implementation of projects as contemplated in Article 204(2) in the previous financial years?

### MOTION

#### INCLUSION OF COMPONENT OF TREE PLANTING IN ROAD NETWORK DESIGNS

THAT, aware that Article 42 of the Constitution accords every person the right to a clean and healthy environment and that Article 69 (1)(d) also mandates the State to encourage public participation in the management, protection and conservation of the environment; further aware that, deforestation is one of the main contributors to climate change; noting that Kenya has not been spared by the effects of global warming and climate change as a result of deforestation, amongst other aspects; also aware that the road network in the country currently stands at approximately 177,800 kilometres with a development rate of 600 km per annum; deeply concerned that there has been persistent destruction of trees and vegetation along the road reserves and roadsides during road construction leading to adverse effects on the ecosystem; cognizant that studies have shown that the benefits accumulated from roadside tree planting include better soil formation due to shedding of dead leaves, increased water quality by reducing sediment flow, reduced erosion, road beautification, flood control as the trees slow and absorb water runoff, wind-breaking, providing important pollinator, habitats, improving people's health and protecting crops; now therefore, this House resolves that the Government includes a component of tree planting in all road network designs and also makes it compulsory for road contractors to replace any tree that is harvested during road construction upon the completion of the project.

*(Moved by Hon. John Kiarie on 10.11.2022)*

*(Debate concluded on 16.11.2022)*

I note and rise under Standing Order 1, that there are no provisions for allowing candidates any sort of presence. There are equally no provisions that prevent their presence within the precincts of Parliament. I wish to invoke and invite you, using Standing Order 1, to allow candidates, perhaps, during voting, access to the Speaker's Gallery or the Public Gallery, as the case may be. I think it is just in order that the people we are voting for witness the process of voting.

That is my point of order and humble request, Hon. Speaker.

**Hon. Speaker:** Order, Hon. Members. Hon. Otiende Amollo, that is a very reasonable request. I order that the candidates to be voted for, if they are within the precincts of Parliament, be given access to the Speaker's Gallery so that they can sit up there, watch and see what is happening during the voting process.

Can the Division Bell be now rung? There are other points of order from Hon. Shakeel and Hon. Okello.

**Hon. Deputy Speaker:** What is your point of order, Leader of the Majority Party?

*(Loud consultations)*

**Hon. Kimani Ichung'wah** (Kikuyu, UDA): Hon. Junet, I am on a point of order. Hon. Deputy Speaker, this political posturing is typical and characteristic of Hon. Junet. It is completely out of order for him to purport that the Member Elect, Hon. Godfrey Mwangi Maina, was rejected by any coalition. The election, and in line with EALA rules, was to be held in this House. It is preposterous and tantamount to say... I would have said very unsavoury things about dynasties and the election of family Members to EALA, but I have restrained myself because as a leader, we are electing Members of the EALA to go and represent Kenya. I wish to congratulate all the nine winners of this election. They need to give priority to the issue of the skewed business by-laws that have been put in place. I am so happy this time for the Azimio la Umoja - One Kenya Coalition side for teaching some people a lesson. They have made sure that we have women and somebody living with disability, but he is very able. We also have women in both sides of the coalitions. So, it is very okay to take people who have potential and understand what we need.

Our fishermen in Busia County were arrested by soldiers from Uganda. I have looked at this team that has made it. I know that they will go and put some things right. We cannot talk of bilateral and multilateral trade, or peace when we are pretending. We need them to go there and start handling these problems, so that we can live in peace in East Africa. **Hon. Gitonga Mukunji** (Manyatta, UDA): Thank you, Hon. Deputy Speaker.

**Hon. Twalib Bady** (Jomvu, ODM): Ahsante Mhe. Naibu Spika. Naungana na wenzangu kuwapongeza sana hawa Wajumbe ambao wameweza kuchaguliwa katika Bunge hili la Afrika Mashariki haswa kutoka Mombasa niko na furaha kubwa sana kumpongeza

mwanzo Mheshimiwa Suleiman Shahbal. Kule Mombasa huwa tunasema Jembe Shahbal. Kwa hivyo, jembe leo limelima.

**Hon. Deputy Speaker:** Hon. James Nyikal, Member for Seme, you have one minute.

**Hon. (Dr.) James Nyikal** (Seme, ODM): Thank you, Hon. Deputy Speaker, for giving me this opportunity. Let me congratulate all the nine Members. They are going there as Kenyans representing the interests of Kenya. However, the bigger interest that the people of the larger East Africa are looking at is an area where we all move and get services freely.

The first election in the East African Community was in 1948 when it was known as the East African Central Legislative Assembly (EACLA) and not the East African Legislative Assembly. Of the 23 Members, only three were Africans and the rest were colonialists. In less than 12 years, they created a thriving community with the East African Railways and Harbours Corporation, the University of East Africa and the East African currency that is now the East African shilling. It was one unit. You could move from Mtwara to Gulu. We expect them to create a bigger unit so that we can move from Mombasa to Kinshasa and from Mtwara to Gulu, without being asked anything as it happened in those days. We shall have achieved a lot. Represent us but build a bigger community and a bigger market that makes Africa what it should be and not small and divided.

With that, I once more congratulate all of you. Build a bigger future.

Thank you, Hon. Deputy Speaker.

**Hon. Deputy Speaker:** Thank you, Hon. James Nyikal, for that historical context. I now call upon the Member for Dagoretti North, Hon. Beatrice Elachi.

**Hon. Beatrice Elachi** (Dagoretti North, ODM): Thank you, Hon. Deputy Speaker. I also join my colleagues in congratulating all the Hon. Members. We believe in you. We have walked the journey with all of you. I have walked the journey with all of you and I know you will change many things.

I went to Tanzania the other day and realized that their trucks and *matatus* have cameras. The Deputy Speaker also mentioned that their police are now wearing body cameras. Very soon, our people will experience challenges as they move there.

**Hon. Deputy Speaker:** Member for Kajiado West, Hon. George Sunkuyia. Finally, I will give an opportunity to the Member for Kiambaa, Hon. John Kawanjiku. You each have one minute, kindly.

**Hon. George Sunkuyia** (Kajiado West, UDA): Thank you, Hon. Deputy Speaker. I take this opportunity to congratulate the nine elected Members of the East African Legislative Assembly led by Hon. Omar, Hon. Sankok, Hon. Mwangi, the young man and the rest. As you go there, kindly deal with the issues affecting our region. There was the issue of auctioning off

of livestock that happened last time, the issue of chicken sellers and the frequent arrests of people. Kindly represent us. Do not stop talking. Make sure our people are represented.

**Hon. Deputy Speaker:** Hon. Kawanjiku. Hon. Mishi, I saw you rushing in, but you are late. You are time-barred. I will only allow the Member for Ijara because I thought he had spoken. After that, the House will rise.

**Hon. Njuguna Kawanjiku** (Kiambaa, UDA): Thank you, Hon. Speaker. I take this opportunity to congratulate the elected Members to the East African Legislative Assembly. I also want to congratulate the Office of the Clerk for conducting a successful election this afternoon.

Always remember that Kenya comes first before anything else. We have a very

robust and growing population that requires the East African Community and you are the people to make it happen for this country.
