- 1. The Senate assembled at thirty minutes past Ten O'clock.
- 2. The proceedings were opened with Prayer said by the Speaker.

3. QUORUM IN THE HOUSE

The Speaker, having counted the Honourable Senators present at the commencement of the Sitting and confirming that there was Quorum, pursuant to Standing Order 40, invited the Clerk to call the Orders of the day.

5. **COMMUNICATIONS FROM THE CHAIR**

a) Convening of a Special Sitting of the Senate

The Speaker conveyed the following Communication from the Chair-

"Honourable Senators.

I welcome you to this Special Sitting of the Senate. As this may be the first time in 2023 that we are meeting, allow me to take this opportunity to wish you a Happy and Prosperous New Year!

On the request of the Senate Majority Leader vide letter Ref. No. SEN/MLS/01/CORR, dated 16th January, 2023, and with the support of the requisite number of Senators, I appointed today, Thursday, 19th

January, 2023 as a day for a Special Sitting of the Senate, vide Gazette Notice No.455 dated 17th January, 2023.

In the *Gazette Notice*, I indicated that the business to be transacted at this Special Sitting shall be –

- (i) the swearing-in of Hon. William Kipkemoi Kisang, the Senator-Elect for Elgeyo Marakwet County; and
- (ii) the consideration of the Independent Electoral and Boundaries Commission (Amendment) Bill (National Assembly Bills No. 49 of 2022).

Honourable Senators,

In accordance with Standing Order 33 (5), the business specified in the *Gazette Notice* referred to above and as outlined in the Order Paper, shall be the only business before the Senate during the Special Sitting, following which the Senate shall stand adjourned until Tuesday, 14th February, 2023, at 2:30 p.m., in accordance with the Senate Calendar.

c) Convening of hybrid Sittings

"Honourable Senators,

At its meeting held on Wednesday, 18th January 2023 the Senate Business Committee considered the Order Papers for the morning and afternoon Sittings of today's Special Sittings. The Committee noted that the business before the Senate is critical and of utmost urgency noting that the vacancies in the Independent Electoral and Boundaries Commission.

Honourable Senators,

During the deliberations the Senate Business Committee noted that some Members of four Standing Committees namely the Standing Committee on Health, the Standing Committee on Agriculture Livestock and Fisheries, the Standing Committee on Devolution and Intergovernmental Relations and the Standing Committee on National Security Defense and Foreign Relations, are out of the country on official business. The number of Senators in these Committee engagements are substantial and may affect the threshold required to vote on the Bill under consideration.

Honorable Senators,

Considering these circumstances, and pursuant to Standing Order 258(1)(a) I designated today's Special Sittings to be hybrid to enable Honourable Senators who are out on official Senate business to participate. Therefore, pursuant to Standing Order 259(1), I issued a notice in today's Order Papers to the effect that today's Sittings will be hybrid and I indicated the online platform to be used.

Further, pursuant to Standing Order 258(4), I issued guidelines to the effect that only those Senators in the cited Committee delegations will be allowed to participate virtually.

Part XXXII of the Senate Standing Orders on Virtual Sittings, will apply during the hybrid Special Sittings. The Senate stands guided".
