- 2. The Proceedings were opened with Prayer
- 3. **Presiding –** the Hon. Speaker

4. **QUORUM**

There being no Quorum present at the commencement of the Sitting, the Hon. Speaker ordered that the Quorum Bell be rung for ten minutes;

And Quorum having been attained before expiration of ten minutes, proceedings commenced.

5. COMMUNICATION FROM THE CHAIR

The Speaker conveyed the following Communication -

The Status of the County Governments Grants Bill (Senate Bill No. 35 of 2021

"Honourable Members.

You will recall that the National Assembly passed the County Government Grants Bill (Senate Bill No. 35 of 2021) on Thursday, 2nd December 2021 with amendments. Subsequently, the Senate was informed of the decision of the House on Friday, 3rd December, 2021.

Honourable Members, on 21st December, 2021 the Clerk of the Senate communicated the decision of the Senate on County Government Grants Bill, 2021 and the appointment of Members to the Mediation Committee. Consequently, on 23rd December, 2021, I communicated to the Senate the progress made by the National Assembly with regard to the said Bill, i.e. the appointment of the following Members to represent the National Assembly in the Mediation Committee on the Bill–

- 1) The Hon. Kanini Kega, CBS, MP;
- 2) The Hon. (Dr.) Kanyuithia Mutunga, MP;
- 3) The Hon. Naisula Lesuuda, OGW, MP;
- 4) The Hon. Millie Odhiambo-Mabona, CBS, MP; and
- 5) The Hon. (Dr.) Makali Mulu, MP.

Honourable Members, to this end, the first meeting of the mediation committee was scheduled on Wednesday, 19th January, 2022 at 9.30 a.m. at the Mini-

Chambers, County Hall, Parliament Buildings. However, the meeting did not take place and was postponed to Tuesday, 25th January, 2022 at 10a.m., which was further postponed on account of the Senate counterparts were holding a Special Sitting on the appointed date, to consider the Political Parties (Amendment) Bill, 2021.

The 3rd meeting was called on 15th February, 2022 in Red-Cross Building, Parliament Buildings at 11.00 a.m. However, it was postponed due to the fact that the four (4) members from the National Assembly were engaged in the Budget and Appropriations Committee retreat to consider the 2022 Budget Policy Statement.

Honourable Members, with the foregoing, efforts to call for a subsequent meeting has not borne fruit on account that the National Assembly Budget and Appropriations Committee has been considering the 2022 Budget Policy Statement and the Financial Year 2021/22 Supplementary Estimates I. In this case, the Mediation Committee on the County Government Grants Bill (Senate Bill No. 35 of 2021) has so far not held any meeting to deliberate on the Bill as required under Standing Order 149.

Honourable Members, the Bill once passed will unlock the conditional grants for county governments and many stakeholders have been inquiring on its status. It is quite disturbing then that the mediation process has not taken off.

In the circumstances, Honourable Members, noting the importance of the said Bill, I direct the Chairperson, Budget and Appropriation Committee and other Members of the Mediation Committee to avail themselves and attend the meeting of the Mediation Committee. In the event that the members fail to meet within seven days, I will call upon the leadership of the House to nominate other members to sit in the Committee.
