4. **THAT**, the 172.8 Acres of land occupied by the residents of Mnarani is registered as plot No: YSR130 Section V situated at Mnarani-Kilifi Takaungu in the name of Kalthum Binti Mohammed and Shariffa Binti Mohammed (referred as Mohammed family) as an Agricultural land;




