## **EXECUTIVE SUMMARY**

The Constitution of Kenya, 2010 under Article 227 mandates Parliament to enact a legislation to provide for amongst others protection or advancement of persons or categories of persons or groups that had historically been disadvantaged by unfair competition. To that end, the Public Procurement and Asset Disposal Act, 2015 (the Act) was enacted and came into force on 7<sup>th</sup> January, 2016. The Act under Part XII provides for promotion of the aforementioned groups through different forms of preference and reservation schemes in public procurement. Specifically, Section 157 focuses on disadvantaged (women, youth and persons living with disabilities); of which Section 157 (5) further instructs accounting officers to ensure they reserve not less than 30% of their procurement spend to disadvantaged groups.

As consequence, Section 157(12) & (13) of the Act directs all public entities to report to the Authority every six months on the number and value of contracts awarded to the target groups. In addition, to ensure uniform and consistent reporting, the Authority developed and disseminated templates for reporting by public entities via PPRA Circular No. 01/2016 of 16<sup>th</sup> December, 2016.

To ensure compliance with Section 157(14) of the Act, the Authority has analyzed and consolidated the reports received from public entities and hereby submits the report to Parliament for consideration and necessary action. The report is generally organized into three parts: Part One presents background information; Part Two presents level of compliance with the requirement to reserve at least 30%; and lastly, Part Three details the number and value of contracts awarded to the disadvantaged groups.

### **1. Reporting Status of Procuring Entities**

During the reporting period, only **179 procuring** entities submitted reports on contracts awarded to enterprises owned by youth, women and PWDs; of which, **158** were from National Government and **21** from the County Governments (comprising of **13** County Executives and **8** County Assemblies). The National Government procuring entities comprised of **20** Ministries and State Departments (Ministries 11%); **100** State Corporations (State Corps 56%); **26** Universities, Colleges, Polytechnics and Technical and Vocational Training Institutions (UCPTs 14%); and **12** Constitutional Commissions and Independent Offices (CIOs 7%)

This Half Year under review has recorded a **1.70 %** increase in the number of procuring entities that submitted reports to the Authority on contract awards to the target groups; from 179 currently to **176** in the previous half-year (July



- December 2021). However, majority of procuring entities have persistently failed to submit reports to the Authority as required by the law.

## 2. Reservation of Procurement Spend for the Disadvantaged Groups

Out of the **179** procuring entities from National and County Governments that reported, **71** did not disclose their procurement budget. Those that reported on their procurement budget (**108**) cumulatively planned to spend Kshs. **148,419,048,238.41** on procurement of goods, works and services. Of this amount, Kshs. **27,992,489,904.54** was reserved for procurement of goods, works and services from firms owned by youth, women and PWDs. This represents an average reservation of **18.86 %** of the cumulative planned annual procurement spend. This is equivalent to 11.14% less than the required 30% reservation and translates to a value of **Kshs. 16,533,881,973.76 of all disclosed procurements** denied to the disadvantaged groups.

The level of reservation and absorption by Ministries and State Departments was not estimated due to incomplete disclosure by the procuring entities. County Executives reserved the most procurement at **42.1%** with the state corporations reserving the least procurements at **14.85%**, while Ministries and state departments, Public Universities and Colleges and constitutional commissions and independent offices reserved **31.68%**, **28.71%**, and **26.17%** respectively. Constitutional commissions and independent Offices reserved the least at (**16.91%**). The figure presents the average levels of reservation and absorption of procurement spend by category of procuring entities. The picture relayed here can be interpreted that procuring entities are reserving procurements for uptake by the enterprises owned by youth, women and PWDs, but the uptake of the reserved procurement spend is still low amongst different categories of procuring entities.

## 3. Contracts Awarded to the Disadvantaged Groups (youth, women and PWDs)

In terms of number and value of contracts awarded to the disadvantaged groups, the procuring entities that reported awarded a total of **16,220**. **It was found that**, majority of the contracts were awarded by State Corporations and SAGAs, followed by Universities, Colleges, Polytechnics and Technical Institutions. County Executives and County Assemblies awarded the least number of contracts to the target groups.

When disaggregated by category of disadvantaged groups, the women category was awarded the highest number **61.65%**. Youth awarded **31.28%** whereas PWDs received the least at **7.07%**. In terms of value of contracts awarded, the women category received the highest value (**56.95%**) whereas the Youth and PWDs categories were awarded **36.44%** and **6.62%** respectively.

In terms of value of the contracts awarded to the target groups, the total value of contracts awarded are worth Kshs. **15,067,625,199.55**. This was

disaggregated into **15,611** contracts of **Kshs. 14,135,670,255.41.10** by National Government entities and **609** contracts worthy **Kshs. 931,954,944.14** by County Government entities. State Corporations reported the highest amount followed by Universities and colleges, County Executives, then by Ministries and State Departments. Constitutional Commissions, Independent Offices and County Assemblies reported the least amounts, synonymous with their low levels of reporting.

In summary, all categories of procuring entities that reported exude that women received a whopping 57% being the highest value of contracts awarded to a single category. Youth and PWDs were awarded a paltry 36% and 7% respectively.

We further noted that a number of public entities did not reserve at least the required minimum of **30%** of their procurement spends to the target groups. Additional observation was on low levels of absorption of the amounts reserved for the disadvantaged groups.

## **PART ONE: BACKGROUND INFORMATION**

### **1.1**

The public procurement and asset disposal system is anchored in the Constitution of Kenya 2010 (the Constitution) under Article 227 (2) (a & b) which specifically states that an Act of Parliament shall prescribe categories of preference in the allocation of contracts and protection or advancement of persons or categories of persons or groups previously been disadvantaged by unfair competition.

### **1.2**

The Public Procurement and Asset Disposal Act 2015 (the Act) was enacted by Parliament and became effective from 7<sup>th</sup> January, 2016. The Act was prepared to give effect to the provisions the procurement law with the Constitution and aspirations contained in the Kenya Vision 2030. The Act also clarified the role of the National Treasury as the policy developer, Public Procurement Regulatory Authority as regulator, Public Procurement Administrative Review Board as an adjudicator in tendering and asset disposal procedures. It also established the County Treasury to be responsible for monitoring public procurement and asset disposal procedures at the county level.

### **1.3**

The Act underscores the need to promote local industry and provide procurement opportunities to the disadvantaged and marginalized groups. These provisions are covered under Part XII of the Act on Preferences and Reservation in Procurement. Specifically, the Act provides for Preferences and Reservations under Section 155 through to 158 setting out the eligibility, target groups, application and monitoring of the scheme.

### **1.4**

Section 157 (12) & (13) of the Act instructs procuring entities at the National and County levels to submit reports to the Authority every six (6) months demonstrating compliance with the legal provisions on implementation of the preferences and reservation scheme. The report should contain disaggregated data indicating the number of youths, women and persons with disability (PWDs) from whom goods, works and services have been procured by the procuring entity as required under Section 157 (13) (b) of the Act. This is a mandatory report to be submitted to the Authority to enable preparation of a report to Parliament pursuant to Section 157 (14) of the Act. It is against this background that this report has been prepared and being submitted to Parliament for consideration.

**1.5**

This report presents the performance of the special groups under the 30% preference and reservation scheme during the First-Half (July-December, 2021) of the 2021/2022 financial year is presented in two (2) parts. Part 1 presents the allocation/setting aside of the 30% procurement budget to the target groups; women, youth and people with Disabilities (PWDs) while Part 2 depicts the contract awards to the target groups in terms of number and value. Further each part is segregated by National Government and County Government procuring entities.

**1.6**

In order for procuring entities to prepare and submit this report in line with Section 157(12) and (13) of the Act, the Authority issued reporting guidelines vide PPRA Circular No. 1/2016 of 16<sup>th</sup>December, 2016; revised through PPRA Circular No. 01/2021 of April, 2021 to all Accounting Officers. The Circular detailed the formats to be used by the procuring entities when preparing the reports as per the requirements set out in Section 157(13) of the Act. Further, the Circular requires the procuring entities to submit the reports to the Authority within 14 days after end of the half of the Financial Year (i.e., by January 14<sup>th</sup> and July 14<sup>th</sup> respectively).

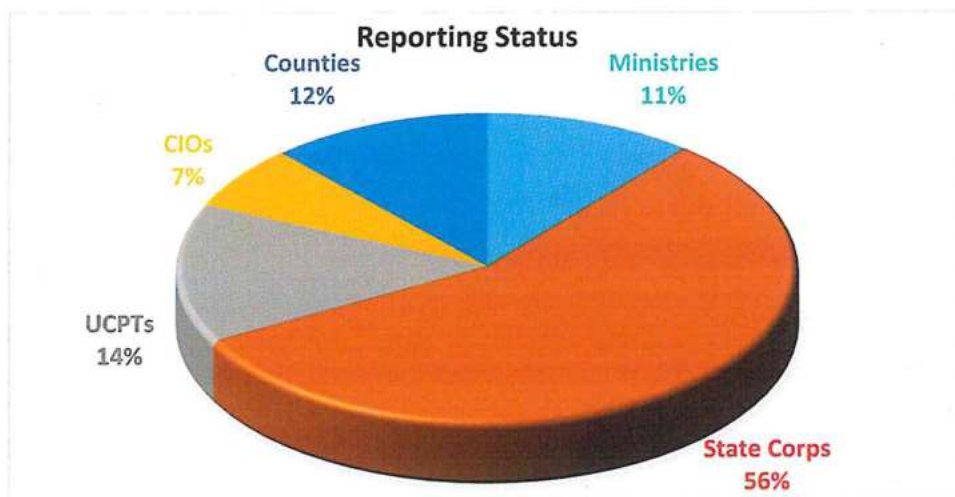
**PART TWO: REPORTING OF PLANNED RESERVATION OF PROCUREMENT SPEND BY PROCURING ENTITIES**

**2.1 Background**

Section 155 of the Public Procurement and Asset Disposal Act, 2015 (the Act) makes it mandatory for public entities to comply with the provisions of Part XII of the Act on Preference and Reservations in Procurement. Section 53(6), and 157(5) & (10) of the Act requires Accounting Officers of public entities to “... reserve a prescribed percentage of its procurement budget, which shall not be less than 30%, to the disadvantaged group and comply with the Act and the Regulations in respect of preference and reservations.

**2. 2 Reporting of Procurement Plans**

As at the time of compilation of this report, only **179** procuring entities had reported on contracts awarded to enterprises owned by youth, women and PWDs. Out of which **158** were from National Government (88%) and **21** from the County Governments (comprising of **13** County Executives and **eight** County Assemblies (Counties 12%). The National Government comprised of **21** Ministries and State Departments (Ministries 11%); **100** State Corporations (State Corps 56%), **26** Universities, Polytechnics, Colleges & Technical Institutions (UCPTs **14%**) and **12** Constitutional Commissions & Independent Offices (CIOs 7%) as detailed in the figure below:-

Thus, there was a decrease in reporting by procuring entities to the Authority during this half-year, compared to the previous period (July- December, 2021), where only 179 procuring entities reported; which was also a drop from

184 in the January – June, 2021 periods. The reports are disaggregated as detailed in Appendix 1.

## PART THREE: PLANNED RESERVATION

### 3.1 Introduction

The procuring entities that reported to have reserved its procurement spend are majorly categorized as follows:

- i) National Government Entities
- ii) County Government Entities

The National Government Entities that reported are disaggregated in the following categories:

- i) Ministries and State Departments
- ii) State Corporations and SAGAs
- iii) Universities, Colleges, Polytechnics and Technical Institutions
- iv) Constitutional Commissions and Independent Offices

The categories of County Government entities that reported entail:

- i) County Executives
- ii) County Assemblies

### 3.2 Reserved Procurement Budget for National Government Entities

During the reporting period, some of the **158** National Government entities, that reported planned to spend cumulatively Kshs. **136,949,064,917.46** on procurement of goods, works and services. Out of which Kshs. **24,843,992,597.28** for procurement of goods, works and services was reserved for firms owned by youth, women and PWDs. This represents an average percentage reservation of **18.4%**, which is below the prescribed minimum of 30% as detailed in the table below:

The PE Categories of Ministries and State Departments (MSDs); and that of Universities, Colleges, and Technical Institutions (UCTIs) reserved its procurement spend over and above the legal minimum of 30%, at 32.45% and 36.14% respectively. The other categories i.e. State Corporations and SAGAs (State Corps); and Constitutional Commissions and Independent Offices (CIOs) were cumulatively not compliant as illustrated in the figure below:

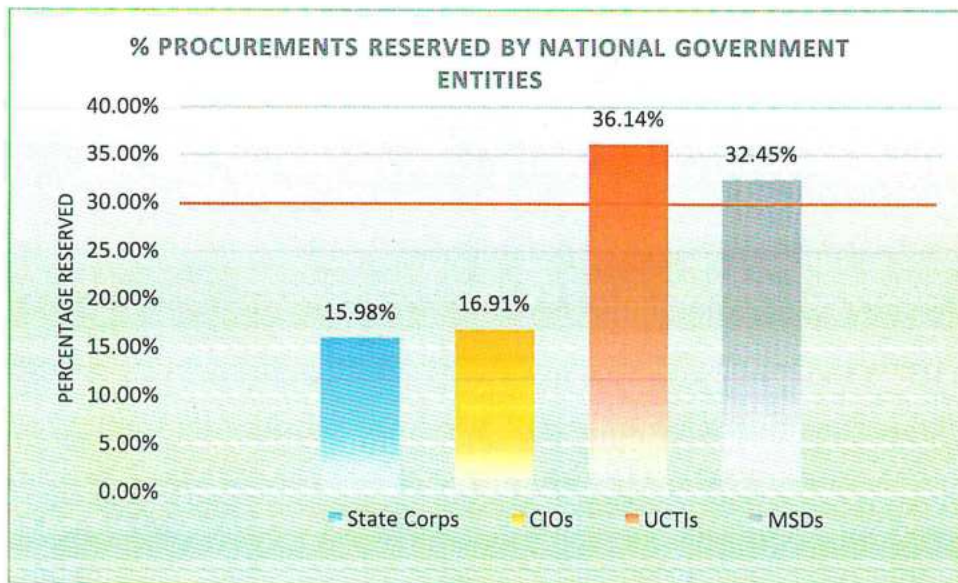


Figure 2: Procurements Reserved by National Government Entities

### 3.2.1 Ministries and State Departments

During this half year period under review, only **20** Ministries & State Departments submitted reports to the Authority on contracts awarded to youth, women and PWDs. Out of the **20**, only **eight** disclosed the annual procurement budgets and amounts reserved for procurements of goods, works and services offered by the enterprises owned by youth, women and PWDs. The **eight** procuring entities planned to spend a total of **Kshs. 9,729,079,093.00** of which **Kshs. 3,157,121,339.00** was reserved for firms owned by youth, women and PWDs. This translated to an average reservation of **32.45%**, which is more than the required minimum of 30%.

From a review of the requirement that procuring entities reserve at least 30% of their total procurement budgets for the target groups; only **eight** out the **20** Ministries and State Departments that disclosed their planned procurement spend and the amounts reserved for the disadvantaged groups, reserved at least 30%. All the **eight** ministries and state departments reserved more that 30% as required except the State Department of Infrastructure, which reserved only **27.56%**.

The remaining **12** Ministries and State Departments that reported submitted nil reports or did not fully disclose their total planned procurement budget. Failure to set aside procurements for the disadvantaged groups is contrary to the directives of the Authority. , it was therefore not possible to determine their level of compliance with the Act.

The State Department for Co-operatives had the highest reservation rate at 64.14% while the State Department for Infrastructure had the lowest reservation at 27.56% as detailed in the Table below:

### 3.2.2 Constitutional Commissions and Independent Offices

During the period under review, **12** Constitutional Commissions & Independent Offices submitted reports on contracts awarded to the target groups. Out of which, only **seven** entities reported on Procurement Budget and Reserved Procurement Spend. The rest submitted nil reports.

The **Seven** reporting entities planned to spend a total of Kshs. **34,288,734,186.00** for their procurements; of which Kshs. **5,797,317,298.30** was set aside for procurement of goods, works and services from firms owned by youth, women and PWDs. This represented an average reservation of **16.91% of the procurement** as detailed in the table below:

From a review of the requirement that procuring entities reserve at least 30% of their total procurement budgets for the target groups; in all the **seven** entities that reported on the procurement spend and reservation budget reserved at least 30% of their procurements for the target groups, only **three**

entities, namely Office of the Auditor General; Teaches Service Commission; and Commission of Revenue Allocation did not comply with the legal requirement. This culminated into an average reservation level of **16.99%** for all the seven entities.

The remaining Constitutional Commissions & Independent Offices that submitted nil reports are as follows:

### 3.2.3 State Corporations and Semi-Autonomous Government Agencies (SAGAs)

During this reporting period, only **100** State Corporations and SAGAs submitted reports to the Authority on contracts awarded to the youth, women and persons with disabilities (PWDs). Of this number (**100**), only **63** disclosed both annual procurement budget and the amount reserved for the target groups for the 2021/2022 financial year.

The **63** State Corporations and SAGAs that disclosed both annual procurement budget and reserved procurement spend, planned to cumulatively spend Kshs. **87,795,707,468.80** on their procurements; of which they reserved Kshs. **14,033,747,340.75** for procurement of goods, works and services from the firms owned by the target groups (Youth, Women and PWDs).

This represented an average reservation of **15.98%** which is less than the required minimum of 30%. **Table 5 below** presents the list of procuring entities under this category that reported and their level of reservation of the at least **30%** of procurement budgets for the target groups.

### 3.2.4 Universities, Colleges, Polytechnics and Technical Institutions

During this reporting period under review, only **26** Universities, Colleges, Polytechnics and Technical Training Institutions submitted reports to the Authority on contracts awarded to the youth, women and persons with disability (PWDs). Out of the **26**, only **18** fully disclosed their total procurement spends and the amounts reserved for the target groups. Meanwhile, two other institutions namely; Wote Technical Training Institute and University of Nairobi only disclosed the reserved amounts but failed to reveal the total procurement budget thus making difficult determine the reserved percentage.

During the period under review, the 20 Universities, Colleges and Technical Training Institutions planned to cumulatively spend Kshs. **5,135,544,169.85** on their procurements; of which they reserved Kshs. **1,855,806,618.90** for procurement of goods, works and services from the firms owned by the target groups (Youth, Women and PWDs), being **36.14%** of the total procurement budget as detailed in the Table below:

### 3.3 County Government Procuring Entities

During the period under review, only twenty-one (Placeholder1) (**21**) County Government entities submitted reports to the Authority. Out of the **21**, only **12** entities disclosed the amount planned as well as the amount reserved for the target groups. The 12 entities from the county government planned to cumulatively spend **Kshs. 11,434,052,799.95** on procurement of goods, works and services, of which **Kshs. 4,594,747,307.25** was reserved for procurement of goods, works and services from firms owned by the youth, women and PWDs. This translated to an average reservation of **40.18 %** of the planned cumulative procurement budget as detailed in the Table below:

#### 3.3.1 County Executives

During the period under review, only **13** County Executives and its entities submitted reports to the Authority on contracts awarded to the youth, women and persons with disabilities (PWDs).

Of the **13**, only seven (**7**) reported a cumulative value of **Kshs. 10,101,932,786.95** of which **Kshs. 4,253,098,203.15** was reserved for procurement of goods, works and services from the firms owned by the target groups (youth, women and PWDs). This represented on average a reservation of 42.10 % which is above the required minimum of 30%, as detailed in the Table below:

### 3.3.2 County Assemblies

During the period under review, only **eight** County Assemblies submitted reports to the Authority on contracts awarded to the youth, women and persons with disabilities (PWDs). Out of the **eight** County Assemblies **3** entities did not disclose planned annual procurement budget as well as the amounts reserved for the target groups, contrary to the directives of the Authority.

The remaining **five** County Assemblies planned to cumulatively spend **Kshs. 1,332,120,013.00** on their procurements for the 2021/2022 financial year of which **Kshs.341, 649,104.10** was reserved for procurement of goods, works and services from enterprises owned by the target groups (youth, women and PWDs). This, on average, represents a level of reservation of **25.65 %** which is below the required minimum of 30%. However, it is noted that only County Assembly of Nyeri reserved the least amount of 6% which is a way too far from below the required thresh hold of 30%. The rest reserved



above the minimum requirements of 30%. The **Table below** presents the list of the County Assemblies that reported and the level of reservation of at least 30% of their procurement spends for the target groups.

### 3.4 Overall Planned Reserved Procurement Spend

Out of the **179** procuring entities from National and County Governments that reported, **71** did not disclose their procurement budget. The 108 procuring entities that disclosed their procurement budget cumulatively plan to spend Kshs. **148,383,117,717.41** on procurement of goods, works and services. Out of this amount, Kshs. **29,438,739,904.53** was reserved for firms owned by youth, women and PWDs as detailed in the Table below:

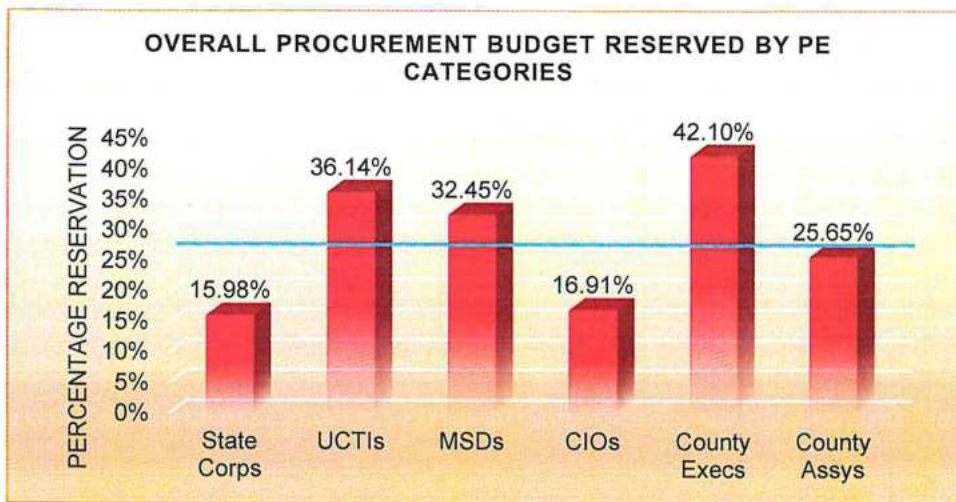

This represents an average reservation of **18.86 %** of the cumulative planned annual procurement spend. This is equivalent to **11.14%** less than the 30%

reservation as required by law. This means **Kshs. 16,533,881,973.76** of all disclosed procurements was not reserved to disadvantaged groups. Overall, it implies that majority of procuring entities at both levels of Government reserved less than the required minimum of 30% procurement spend.

Percentage wise, only the sectors of Universities and Colleges (36.14%); Ministries and State departments (32.45%); and County Executives (42.10%) that cumulatively complied with the 30% reservation requirement. Other sectors such as State Corporations and SAGAs (15.98%); Constitutional Commissions and Independent Offices (16.91%); and County Assemblies (25.65%) on average, failed to comply with the legal requirement of reserving a minimum 30% of procurement budget.

Overall, only the PE Categories of Ministries and State Departments (MSDs); Universities, Colleges, and Technical Institutions (UCTIs); and County Executives reserved its procurement budget over and above the legal minimum of 30% cutline; at 32.45%, 36.14% and 42.10% respectively. County Executives category cumulatively reserved the highest percentage, while Constitutional Commissions and Independent Offices cumulatively reserved the lowest at 16.91%. The other categories i.e. State Corporations and SAGAs (State Corps); Constitutional Commissions and Independent Offices (CIOs); and County assemblies were cumulatively not compliant as illustrated in the figure below:

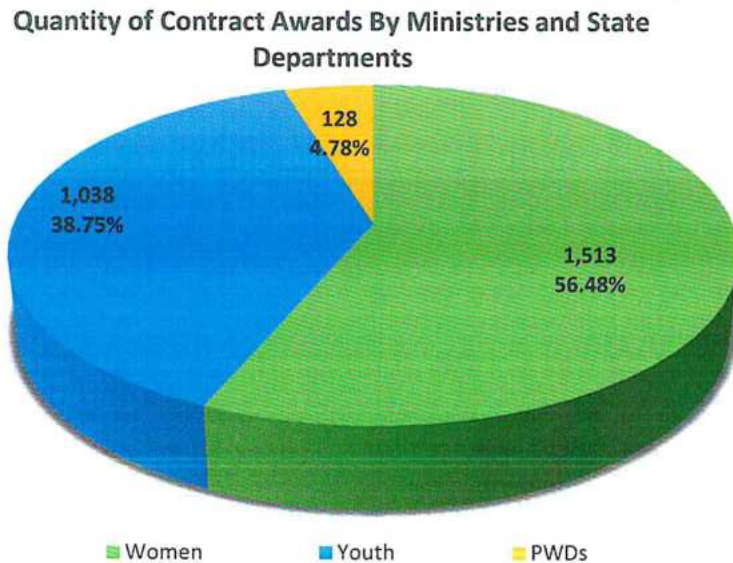

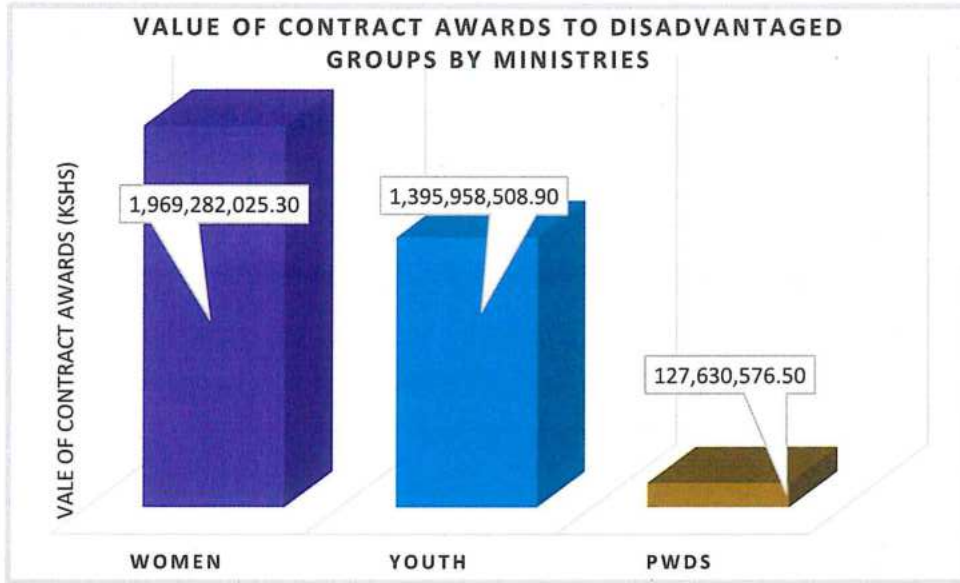

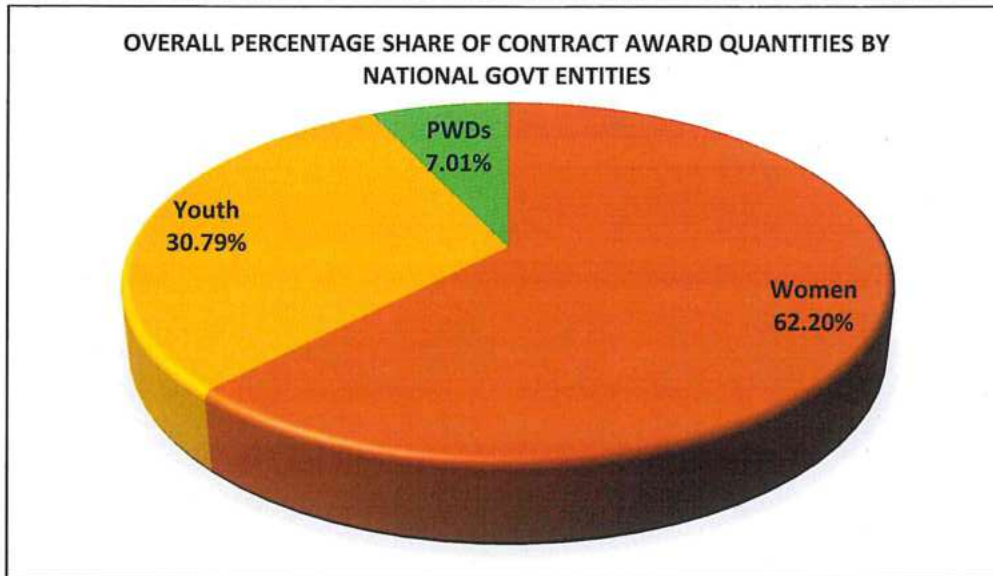

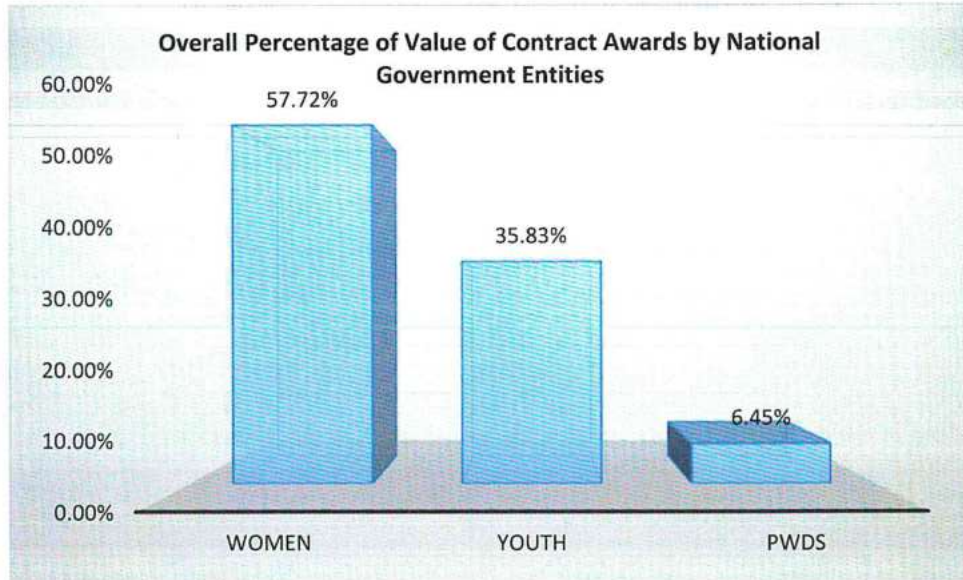
**Figure 8: Overall Percentage Share of Contract Award Quantities by National Government Entities**

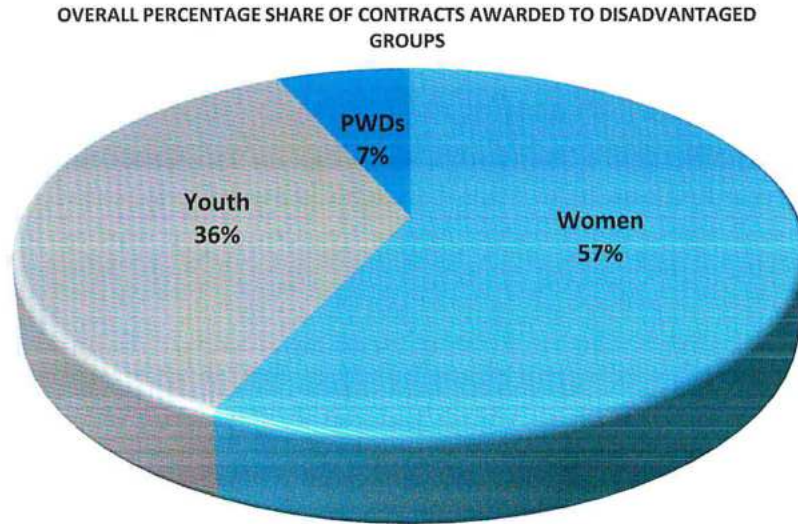

## **PART FIVE: ANALYSIS FOR THE ANNUAL PERFORMANCE FOR THE 2021/2022 FINANCIAL YEAR**

During the **FY2021/2022**, **176** Procuring Entities reported on contract Awards for the First Half (**July-December, 2021**) whereas during the second Half (**January –June 2022**) only **179** procuring Entities reported on the Contract Awards to the Target Group. (Women, youth and PWDs). However, out of the **176** procuring entities that reported on the Contract Awards for the Second Half, **71** Entities did not disclose their total Annual Procurement Budget as well as their reserved Amount. Therefore, comparison on Contract Awards for the Target Group for the FY 2021/2022 was not possible due to inconsistency on reporting by procuring entities. It is worth noting that most of the procuring entities that reported on Contract Awards for the First Half did not report on the Contract Awards for the Second Half. The table below is a summary of Reserved Procurement Spend by procuring entities for the First Half (July-December2021) and Second Half (January- June 2022).

From the table above, procuring entities that reported on First Half cumulatively planned to spend Kshs. **152,888,184,156.15** on procurement of goods, works and services. Of this amount, Kshs. **30,668,449,779.37** was reserved for procurement of goods, works and services from firms owned by youth, women and PWDs. On the other hand, the procuring entities that reported for the Second Half cumulatively planned to spend Kshs. **148,419,048,238.41** on procurement of goods, works and services. Of this amount, Kshs. **27,992,489,904.54** was reserved for procurement of goods, works and services from firms owned by youth, women and PWDs. This represents an average reservation of **18.86** % of the cumulative planned annual procurement spend.

On cumulative quantity of contract awards, it was found that during the 2021/2022FY, the procuring entities that submitted their reports to the Authority, awarded a total of **32,651** contracts to youth, women and PWDs. Of these contracts, women category received the highest number of 20,026 followed by the youth category at 10,317 while the PWDs received the least at 2,308 contracts. To be precise, during the current half-year **16,431 which is more** than the previous half-year of **16,220**. It was also noted that PWDs were awarded slightly more contracts during this half than the previous one as detailed in the Table below:

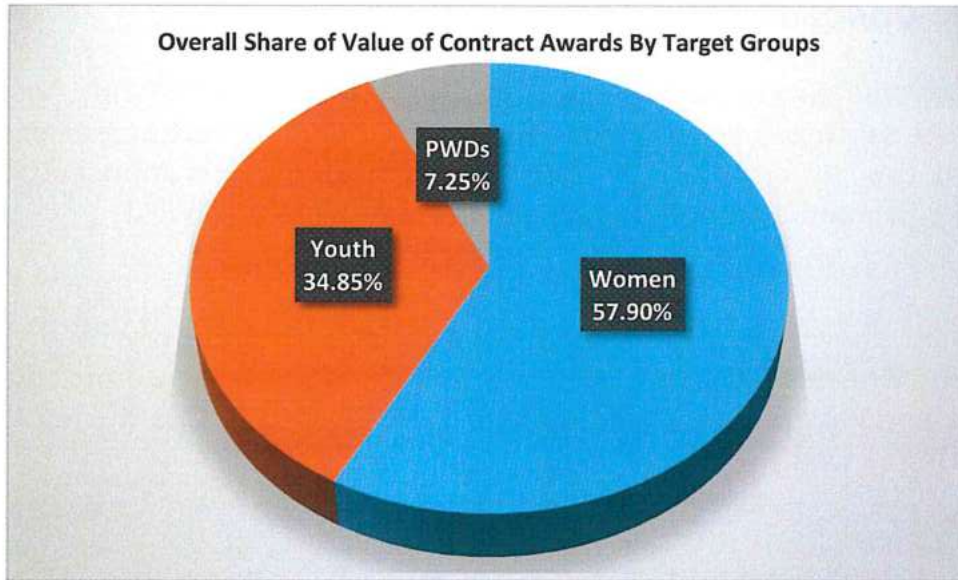

**PART SIX: CONCLUSION**

6.1 This report was prepared pursuant to Section 157 (14) of the Act in fulfillment of the statutory requirement to always report to Parliament every six months on the performance of the preference and reservation scheme targeting youth, women and persons living with disabilities (PWDs).

6.2 As presented above, the Authority noticed a rise in mandatory reporting by the Procuring Entities (PEs) from 176 procuring entities that submitted the reports for the previous period (July–December, 2021) to 179 PEs during this current reporting period.

6.3 After reviewing the submitted reports; a number of issues were noted; which included:

- a) A number of procuring entities did not disclose all the information required, in terms of the annual procurement budgets and the amounts reserved for the target groups, thus we were not able to determine their level of compliance with Section 157(5) of the Act.
- b) A number of procuring entities reserved less than the required minimum of 30% of their annual procurement budget for the preference and reservation scheme, which is contrary to provisions of Section 157(5) & (13) of the Act.
- c) Some procuring entities have classified some of their procurements as complex and specialized or security based therefore cannot be reserved for the disadvantaged groups.
- d) Despite procuring entities reserving procurement budgets for the disadvantaged groups (youth, women and PWDs), absorption of the same has been very low across all categories of procuring entities. There is need to find out the factors that impede PEs from spending the reserved budgets.
- e) PWDs category was awarded the least contracts in terms of number and value by all the procuring entities that reported. Some procuring entities did not award contracts to this target group at all.
- f) Despite the circular on mandatory reporting issued by the Authority to all procuring entities (across all categories), and other reminder Circulars by the Cabinet Secretary of the National Treasury and Planning, most of

the procuring entities are still not submitting mandatory reports as directed.

- g) A number of procuring entities reported that their procurement activities during the half- year were greatly affected by the Corona Virus pandemic.

6.4 A number of milestones have been achieved under the preference and reservation scheme including: The National Treasury and the Authority have issued directives in form of circulars to Accounting Officers on implementation requirements as part of the operationalization of preferences and reservations. Further, the two institutions have continued to build the capacity of procuring entities and suppliers to enhance uptake of the programme. Notwithstanding these major achievements, the uptake of the 30% procurement spends reserved for the target groups are still low.
