7. **QUESTIONS AND STATEMENTS**

STATEMENTS

a) Pursuant to Standing Order 52(1)

i.) Nominated Senator (Sen. Hamida Kibwana, MP) made a Statement on the State of health and safety in schools following the tragedy at Mukumu Girls' High School in Kakamega County.

Thereupon, the Senator expressed concern over the tragic loss of four lives at Mukumu Girls' High School, following the infection of scores of students from alleged contaminated food and water. She noted that a similar tragedy claimed the lives of two students at the same school in 2022.

The Senator called for a comprehensive and open inquiry into the incidents and the prompt implementation of the recommendations made by Quality Assurance Officers following the tragedy of 2022.

The Senator also called for regular safety inspections, channeling of adequate resources to ensure that necessary infrastructure and facilities are in schools and the sensitization of students, staff, and parents on proper hygiene.

The Senator concluded by pointing out that education was a fundamental right and that all stakeholders were obligated to ensure that every child has the opportunity to grow and learn in a safe setting, free from the fear of illness or harm.

The Senator also stated that KEWOSA would engage with government agencies, the Kenya Women Parliamentarians Association (KEWOPA), civil society organizations and international partners to build partnerships and leverage resources to promote public awareness and education on issues affecting women and vulnerable groups, and foster a culture of respect, tolerance and inclusiveness.
