7. QUESTIONS AND STATEMENTS

a) Statements Pursuant to Standing Order 53(1)

(i) The Senator for Kiambu County (Sen. Karungo Thangwa, MP) sought a statement from the Standing Committee on Lands, Environment and Natural Resources regarding the delay in compensation to residents of Ndeiya, following compulsory acquisition of private land for expansion of the Standard Gauge Railways.

- (ii) Nominated Senator (Sen. Beatrice Ogola, MP) sought a statement from the Standing Committee on Land, Environment and Natural Resources regarding the state of rehabilitation works and water supply restoration from Ndhiwa borehole.
- (iii) The Senator for Kisumu County (Sen. (Prof.) Tom Ojienda, MP) sought a statement from the Standing Committee on Health regarding the state of healthcare and medical services offered at Jaramogi Oginga Odinga Teaching and Referreal Hospital (JOOTRH).
- (iv) The Senator for Kisumu County (Sen. (Prof.) Tom Ojienda, MP) sought a statement from the Standing Committee on Trade, Industrialization and Tourism concerning measures to enhance tourism resources and tourist potential in Kisumu County.
- (v) The Senator for Kisumu County (Sen. (Prof.) Tom Ojienda, MP) sought a statement from the Standing Committee on Land, Environment and Natural Resources regarding the water and sanitation in Katito town in Kisumu County.
- (vi) Statement by the Senator for Lamu County (Sen. Joseph Kamau, MP) to the Standing Committee on Land, Environment and Natural Resources regarding the alleged encroachment of land in Lamu County was **dropped** in the absence of the Senator.

b) Pursuant to Standing Order 56 (1) (a)

The Chairperson, Standing Committee on Devolution and Intergovernmental Relations, (Sen. Sheikh Mohamed Abass, MP), issued a Statement concerning the closure of sixteen County Assemblies.

Thereupon, the Chairperson informed the Senate that the Committee received correspondence from a group of Members of the County Assemblies named the Association of Members of County Assemblies (AMCA) which represents over 2000 Members across the country, which indicated that within fourteen (14) days, all forty seven (47) county assemblies would adjourn indefinitely owing to a number of grievances. The Chairperson informed the Senate that the fourteen (14) days had since lapsed, following the issuance of the notice on 3rd May 2023. Consequently, sixteen (16) County Assembly had adjourned sine die.

In light of the emerging situation in the county assemblies, the Committee undertook an investigation, including holding a meeting with the County Assemblies Forum (CAF) and the Executive Members of the Association of Members of County Assemblies (AMCA) to listen to their concerns. Following these meetings, the following issues arose –

- i.) That county assemblies require financial autonomy to effectively execute their mandates;
- ii.) That remuneration and benefits of members of county assemblies need to be reviewed by the Salaries and Remuneration Commission (SRC);
- iii.) That SRC be advised to reinstate the plenary allowances for MCAs being the best practice at the national level and all legislative assemblies in the World;
- iv.) That Kenya Revenue Authority (KRA) be required to revoke, revert and refund the 30% tax levied on Members Car Reimbursement; and
- v.) That there was need for the Pension and Gratuity terms of Members of County Assemblies to be provided for.

Consequently, the Committee undertook to make amendments to relevant statute for anchoring CAF in to law and to schedule a meeting with the SRC and the KRA to discuss the issues concerning remuneration and benefits of the MCAs. In the meanwhile, the Chairperson urged all parties to resort to consultation and dialogue as the outstanding issues are being resolved.
