- 1. The Senate assembled at thirty Minutes past Two O'clock.
- 2. The proceedings were opened with Prayer said by the Speaker.

3. **COMMUNICATIONS FROM THE CHAIR**

Twenty-three (23) Motions are pending conclusion before the Senate while Fourteen (14) Petitions have matured for reporting by respective

Committee Chairpersons. In addition to these, one hundred and seventy (170) Statements are pending conclusion by Standing Committees. I urge the responsible Committees to expeditiously consider the Petitions and Statements before them and table reports pursuant to the Standing Orders.

From the aforementioned, it is clear that, the Senate resumes its sittings with a heavy in-tray. The Speaker will do whatever is necessary within the Standing Orders to expedite consideration of business scheduled in the Order Paper, but the Speaker alone, cannot move business. It goes without saying that Movers of business listed in the Order Paper must be in the Chamber to prosecute the same. Party Whips will be required to ensure that the requisite number of county delegations is achieved for divisions to be undertaken at the right time, if we are to clear the backlog on Bills and Motions.

6. **STATEMENTS**

a) Pursuant to Standing Order 52 (1)

The Senator for Tana River County (Sen. Danson Mungatana, MP) made a Statement concerning the Joint African Union (AU)-Pan-African Parliament (PAP) Electoral Observation Mission on the General Elections held on 24th June, 2023, in the Republic of Sierra Leone.

The Senator informed the Senate that Sierra Leone holds general elections every five years and that the General Elections held on 24th June, 2023, were the fifth since the end of the civil war in 2002. The Senator further informed the Senate that the African Union deployed an election observation mission to Sierra Leone for the 2023 General Elections and that the mission undertook multiple pre-election activities including sensitization workshops for observers; mapping of polling centres; and consultations with major stakeholders.

The Senator highlighted that the overall assessment of the Observer Mission was that the elections were relatively peaceful and credible. This was a stark difference to previous elections in the country, which were highly competitive and witnessed divisive political rhetoric. The Senator commended the Sierra Leone Association of Journalists, the Independent Radio Network in Sierra Leone, the Inter-Religious Council of Sierra Leone and the West African Elders Forum for their role in ensuring peaceful and transparent elections.

The Senator concluded by urging relevant government agencies and the Standing Committee on Justice, Legal Affairs and Human Rights, to emulate the Sierra Leone experience, and review legislation with a view to put in place measures aimed at promoting citizen participation, peace building during elections and enhanced transparency and credibility of elections in Kenya.
