PUBLIC PETITION

**ON PAYMENT OF RETIREMENT DUES AND PENSION FOR
RETIRED TEACHERS**

I, the UNDERSIGNED, on behalf of the retired teachers of Mwatate Constituency and other retired teachers across the country;

DRAW the attention of the House to the following:

- 1. THAT**, the government provides retirement benefits to public officers as part of their terms of service, with a view to providing them with social security in old age as stipulated in Article 43(1)(e) of the Constitution;
- 2. THAT**, the provision of retirement benefits to public officers is intended to ensure a smooth transition from active service with employment income, to retirement with a certain level of replacement income. This is so that the standard of living for public officers does not change drastically in old age;
- 3. THAT**, the Pensions Act (Cap.189) makes provisions for granting and regulating the payment of pensions, gratuities and other allowances in respect of the public service for officers under the Government of Kenya;
- 4. THAT**, despite the foregoing provisions, there are retired teachers in the Republic of Kenya who served under the Teachers Service Commission (TSC) who have never been paid their retirement dues and pension;
- 5. THAT**, in Mwatate Constituency just like other constituencies in the Republic of Kenya the said retired teachers served in different schools and retired in different years;




PUBLIC PETITION ON PAYMENT OF RETIREMENT DUES AND PENSION FOR RETIRED TEACHERS

- 6. **THAT**, in Mwatate Constituency, some of the retired teachers have neither been communicated to by their employer, TSC up to date nor paid their monthly pension and or the lumpsum for the services they offered during their years of service;
- 7. **THAT**, the continued non-payment of the retirement benefits and pensions have subjected teachers to live in deplorable state;
- 8. **THAT**, the non-paid retired teachers of Mwatate Constituency retired from the period ranging 2011 and 2022 and some of them are now suffering ailments associated with old age hence causing them unbearable financial needs;
- 9. **THAT**, the issues in respect of which this Petition is raised are not pending before any court of law, or any constitutional or legal body;
- 10. **THEREFORE**, your humble petitioners pray that the National Assembly through the Public Petitions Committee—
 - i. Engages the TSC to establish the circumstances that have occasioned the delayed payment of retirement benefits of the retired teachers in Mwatate Constituency and the entire country;
 - ii. Engages the TSC to provide data and statistics of all unpaid retired teachers in the entire country and indicates when they will pay all the retirement dues of the said teachers; and
 - iii. Makes any other recommendation or action it deems fit in addressing the plight of the Petitioners.

I, the **UNDERSIGNED**, on behalf of the retired teachers in Mwatate Constituency;


DRAW the attention of the house to the following:

1. **THAT**, they are retired teachers who had served in the Republic and Government of Kenya through the Teachers Service Commission in different number of years;
2. **THAT**, they all served in different schools in Taita Taveta County and other counties in the republic;
3. **THAT**, they all retired;
4. **THAT**, some of them:
 - i. Have not been communicated to up to date;
 - ii. Have pension numbers but have not been paid their monthly pension and lump sum;
 - iii. Have pension numbers and are being paid monthly pension but have not been paid there lump sum;
5. **THAT**, there has never been any communication with the employer and treasury on the impediment to their dues and effort made to settle the payment;
6. **THAT**, they are aware of other teachers who either retired with them at same time and were paid earlier than even less than a year;

THEREFORE, their prayers to this house is to compel their employer who is the TSC , the treasury and director of pensions to give reasons why;

1. These teachers have not been paid their retirement benefits to date irrespective of having supplied the respondent with the necessary documents requested a year earlier before retirement dates
2. The efforts being made by the TSC and the treasury to get rid of the cartels who are making teachers to suffer after refusing to bow down to their demands
3. They demand the earliest date when these teachers should expect their dues as some are suffering ailments like diabetes and high blood pressure due to demands on financial needs in their families.
