- 1. The Senate assembled at thirty Minutes past Two O'clock.
- 2. The proceedings were opened with Prayer said by the Speaker.

3. QUORUM IN THE SENATE

The Speaker, having counted the Honourable Senators present at the commencement of the Sitting and confirming that there was no Quorum, caused the Bell to be rung for ten minutes pursuant to Standing Order 40 (1);

And there being a Quorum before the expiry of ten minutes;

The Speaker invited the Clerk to call the Orders of the Day.

4. MESSAGE FROM THE COUNTY ASSEMBLY OF NYANDARUA

The Speaker conveyed the following Message from the Chair: -

"Honourable Senators,

I wish to report to the Senate that, pursuant to Standing Order 48 (3) & (4), I have received a Message from the Speaker of Nyandarua County Assembly, the effect of which is to petition the Senate to consult with the Kenya Wildlife Service, the National Environmental Management Authority, the Kenya Forest Service and other Government Agencies and speed up the Gazettement of Lake Ol'Bolossat as a National Reserve under the County Government of Nyandarua in order to enhance its conservation, address issues of human-wildlife conflict, create job opportunities, enhance own source revenue and provide an alternative source of livelihood to the residents.

The Message was received in the Senate by way of a letter communicating a resolution passed by the County Assembly on 8th March, 2023 which inter alia, provided–

"THAT, AWARE THAT Lake Ol'Bolossat, is the only highland lake in Central Kenya and that it is a significant freshwater source, lies at an altitude of 7,600 feet and is an essential part of the local ecosystem and economy. The lake feeds into the Ewaso Ngiro River, which supplies water to the Thomson Falls, was declared a protected wetland under the Environmental Conservation and Management Act of 1999 (EMCA 1999) in 2018, and spans approximately 4,800 square kilometers;

FURTHER AWARE THAT, the lake is a vital habitat for over 300 bird species migrating between Europe and Asia and houses over 100 hippopotamuses, supports the livelihoods of people, livestock, and wildlife downstream in several counties and supports a variety of activities, including commercial, agricultural and tourism. The lake area also encompasses two major conservancies, Lewa and Olpajeta;

FURTHER COGNIZANT THAT, the Nyandarua County Government, has been in consultation with the National Government Ministry of Tourism, Wildlife and Heritage on the Gazettement of Lake Ol'Bolossat as a National Reserve under the Kenya Wildlife Conservation and Management Act, 2013, to facilitate more effective conservation measures and boost eco-tourism.

CONCERNED THAT, despite these efforts, the lake's ecosystem has significantly dwindled due to human activities, and that its area has shrunk from around 10,000 hectares to about 2,000, leading to a decrease in water levels and a drop in bird and hippopotamus populations and that invasion by local communities with large herds of cattle and encroachment of riparian land has exacerbated the situation, interventions to save the lake and its ecosystem has been limited, causing concern among the public and stakeholders;

The Assembly, thereupon, resolved inter lia -

- i) THAT, the Assembly petitions the Senate of Kenya to consult the Kenya Wildlife Service, the National Environmental Management Authority, the Kenya Forest Service, and other Government agencies, to expedite the Gazettement of Lake Ol'Bolossat as a National Reserve under the County Government of Nyandarua, to augment conservation efforts, resolve human-wildlife conflict, generate job opportunities and enhance own source revenue and provide an alternate livelihood source for locals;
- ii) THAT, the Nyandarua County Government initiates consultations with the Kenya Wildlife Services for a potential partnership to enable the County Government to fully protect the lake and generate revenue from it; and
- iii) THAT, the County Government confers with the National Government on exploiting the lake's resources and establishes a phased plan for biodeposit exploration in the lake.

Honourable Senators,

I direct, pursuant to Standing Order 48(7)(c), that the matter together with the set of correspondence received from the County Assembly of Nyandarua, be referred to the Standing Committee on Land, Environment and Natural Resources for consideration.

I thank you."

6. QUESTIONS AND STATEMENTS

a) Statements pursuant to Standing Order 52(1)

i) On the release of Turkana Pastoralists arrested and jailed in Uganda

The Senator for Turkana County (Sen. James Lomenen Ekomwa, MP) made a Statement concerning a matter of international and general topical concern, namely, the release of Turkana pastoralists arrested and jailed in Uganda. The Senator stated that pastoralists in Turkana County have been facing recurring drought that severely impact the availability of pasture and water for their livestock. He added that due to this, many pastoralists in the County are often compelled to cross over into the neighboring country of Uganda in search for greener pastures and water sources to secure survival for their livestock which is their main source of livelihood.

The Senator highlighted that, more recently, in April 2023, 32 Kenyan pastoralists from Urum and Lokirima Villages in Turkana Counties were arrested by the Uganda People's Defence Forces and police in the guise of disarmament operation, tried in court martial and sentenced to 20 years in jail. Six (6) others suffered gunshot wounds in the same alleged disarmament operation.

The Senator urged the Standing Committee on National Security, Defence and Foreign Relations to inquire into this matter and initiate engagements with the Ministry of Foreign and Diaspora Affairs to secure the release of the arrested pastoralists.

ii) On the International Youth Day

Nominated Senator (Sen. Esther Okenyuri, MP) made a statement on a matter of general topical concern, namely: the International Youth Day. The Senator highlighted that the International Youth Day (IYD) was an annual event observed globally on 12th August in accordance with the United Nations General Assembly (UNGA) Resolution 54/120 of 1999, with the first IYD being observed in 2000. She informed the Senate that the day's aim was to bring youth issues to the attention of the international community as well as to celebrate the potential of youth as partners in today's global society.

Noting that the theme of this year's IYD was, "Green Skills for Youth: Towards a Sustainable World", the Senator stated that the commemoration of the IYD in Kenya would take the form of the celebration of a Youth Week where a flurry of youth events and activities had been planned to run for a full week, beginning Monday, 7th August, 2023, culminating in the IYD on Saturday, 12th August, 2023.

She noted that the United Nations had expanded this year's theme of Green Skills into five major areas of concern and focus as follows: -

- 1) That certain knowledge, abilities, values and attitudes were needed to live in, develop and support a sustainable and resource-efficient society.
- 2) That the youth would endure severe climate events longer. For example, compared to a child born in 1960, how many times more will a child born in 2020 experience extreme climate events in their lifetime? It is posited that they will endure 2.6 times more droughts, 2.8 times more river flooding, 6.8 times more heat waves, 2.8 times more crop failure and 2.0 times wildfires.
- 3) That youth would experience significant changes in economic opportunities since climate change threatens 40% of all jobs that are heavily reliant on a healthy environment.
- 4) That skills demand was exceeding supply. This meant that 60% of young people would lack the skills necessary to thrive in the green economy in 2030.
- 5) That there were disparities that must be addressed, including: -
 - (i) Technology divide: 67% of youth do not have digital skills due to the lack of basic resources;
 - (ii) Education gap: Those with a university education obtain green skills quicker than youth with no university education; and
 - (iii) Current occupational gender stereotypes are likely to persist as it is claimed that the green transition will favor male-dominant sectors. 19 million jobs will be created for men as compared to 6 million for women.

The Senator concluded by urging the Senate to engage with county governments to explore avenues to fast-track imparting the youth with Green Skills for a sustainable world.
