Speaker apprises House on business transacted during the Second Session of the 13th Parliament



peaker of the National Assembly, Rt. Hon. (Dr.) Moses Wetang'ula on Tuesday 13th February, 2024, released a report on the Business the House transacted during the Second Session of the 13th Parliament.

According to the report, 69 Bills were introduced in the National Assembly. Out of this, 17 were passed and assented to into law. In addition, a total of 179 Motions were debated.

"The Motions covered various subject matters including school feeding programmes, access to healthcare in the country, road safety, cost of electricity, and investment incentives in the country as well as social protection measures," Speaker Wetang'ula said when he read out a Communication from the Chair.

He singled out two Bills which were passed on 6th December, 2023 just before the House proceeded on recess and said the President had assented to them and the Acts are now operational.

"I would like to single out the National Government Constituencies Development Fund (Amendment) Bill (National Assembly Bill No. 13 of 2023) and the National Lottery Bill (National Assembly Bill No. 69 of 2023) which were passed on 6th December, 2023. Hon. Members, I wish to inform you that His Excellency the President assented to these two Bills on 11th December, 2023 and the Acts are now in operation," the Speaker added.

Apart from legislation, 114 Petitions were received, out of this 54 were presented to the House.

With regard to Committee business, the Hon. Speaker stated that 151 Reports were tabled by various Committees. These reports covered a range of matters, including Bills, vetting of persons for state office appointments, statutory instruments, inquiries, and petitions

Members demand immediate action to end femicide as House adjourns to discuss the vice


he House adjourned its business to address the alarming surge in violence and brutal killings targeting women in the country.

While moving the adjournment Motion, Hon. Esther Passaris (Nairobi) disclosed distressing statistics, revealing that over 500 women have been killed in the past six years. She criticized the Government's failure to hold perpetrators accountable, citing a culture of impunity hindering deterrence.

"Femicide violates Kenyan women's fundamental Constitutional and human right to life and the freedom from violence," Hon. Passaris said.

Hon. Leah Sankaire (Kajiado), also Chairperson of the Kenya Women Parliamentary Association (KEWOPA), expressed her displeasure with the escalating number of female casualties and called on her colleagues to speak out against this scourge. She also urged proactive engagement from all stakeholders.

"The statistics of femicide victims are grim. As lawmakers, it would be wrong for us to remain silent," Hon. Sankaire said.

Deputy Speaker, Hon. Gladys Boss (Uasin Gishu) echoed similar sentiments, acknowledging the historical prevalence of femicide cases in the country and stressing the need for urgent action.

"In the past, we have lost prominent women in the society including renowned athletes and even a musician. We have been very slow in speaking out against the vice in our country," said Hon. Boss.

Hon Beatrice Elachi (Dagoretti North), who is also the KEWOPA Vice Chairperson, blamed the normalization of gender based violence for fueling the femicide cases.

Hon. Junet Mohamed (Suba East), Hon. Kuria Kimani (Molo), Hon. Caroli Omondi (Suba South), and Hon. Omboko Milemba (Emuhaya) among others, emphasized that femicide is a societal issue, not just a women's problem and called for a holistic solution.

Give all Cabinet Secretaries fair chance to appear before House, urges Speaker

peaker of the National Assembly, Rt. Hon. (Dr.) Moses Wetang'ula has called on the Leader of the Majority Party, Hon. Kimani Ichungw'a to designate time to all Cabinet Secretaries irrespective of how many questions have been brought before them.

The call by the Speaker was prompted by the Gilgil MP, Hon. Martha Wangari, who rose on a Point of Order asking the Speaker to offer guidance on a matter where a legislator files a Question to a Cabinet Secretary, but because there are not enough Questions to warrant an invite to the line Cabinet Secretary, the invite delays.

Hon. Wangari said she had posed a Question to the CS for Gender, Culture, the Arts and Heritage in April, 2023 but since no other lawmaker had a Question directed to the CS, she is yet to be invited to appear before the House.

The matter was further amplified by Hon. Irene Mayaka (Nominated) who noted that she had also filed a Question to the CS for Youth Affairs and Sports regarding life and medical insurance for Kenyan athletes, which was yet to be responded to.

In response, Speaker Wetang'ula noted that while a Cabinet Secretary may not have loads of Questions to trigger their immediate invitation to the House, their appearance before the Plenary Sitting may occasion other Supplementary Questions on a matter of immense national interest, which might otherwise not have been asked.

Noting that the Leader of Majority by virtue of being the interface between the House and the Executive arm of Government is responsible for making invitations to CSs, the Speaker directed Hon. Ichung'wa to facilitate even those CSs who don't have many questions lined up.

"Hon. Majority Leader, you've heard what the MP for Gilgil said. In bringing CSs to this House, it matters not how many Questions have been filed," he said.

The practice requiring Cabinet Secretaries to appear before the House to respond to Members' Questions has been in place since April 2023. This followed the approval, by the two Houses, of a Presidential Memorandum paving way for the amendment of the Standing Orders of both Houses to allow CSs to appear before the House.



Malindi MP wants Teachers Service Commission to address discrepancies in the remuneration of interns in Junior Secondary Schools

alindi MP, Hon. Amina Mnyazi wants top officials of the Teachers Service Commission (TSC) to appear before the Departmental Committee on Education to address discrepancies in the remuneration and terms of service for teachers serving as interns in Junior Secondary Schools (JSS).

The move by the Hon. Member follows concerns and grievances raised regarding the terms of service for teachers working as interns in JSS across the country.

According to reports these teachers are paid a stipend of Kshs17, 000 per month. This, Hon. Mnyazi said is under-payment to persons expected to actualize the new education system. She added that such actions risks derailing the full implementation of the Competency Based Curriculum (CBC).

"This has far-reaching effects, causing emotional, psychological and financial strain on the teachers," Hon. Mnyazi said.

According to the Malindi legislator, confirmation of the interns to permanent and pensionable terms of service needs to be expedited to ensure job security and stability of those critical personnel.

In addition, Hon. Mnyazi said that currently no clerks and accountants are engaged in JSS.

"This has created a loophole in the management and accountability of funds, resulting in deficiencies in procuring essential teaching and learning resources. The current staffing inadequacies, coupled with lack of essential learning resources, hinder effective teaching and implementation of the CBC," she said.

In light of these challenges, she urged the TSC to clarify the timeline and procedure for addressing the concerns raised by intern teachers

▶ FROM PAGE 1 Regarding Business not dispensed with at the end of the Second Session, Hon. Wetang'ula stated that such business had lapsed.

With respect to Questions to Cabinet Secretaries, the Speaker stated that 281 Questions were transmitted to Cabinet Secretaries (CSs), out of which 125 were responded. This therefore, means 156 Questions awaiting response.

"In this regard, where a Member is still desirous of obtaining a response to the transmitted Question(s), I will permit the Leader of the Majority Party to prioritize such Questions when scheduling the appearance of Cabinet Secretaries before the House," Hon. Wetang'ula directed.





Committee on Lands questions National Lands Commission over rejection of proposed amendments to land laws

he Implementation Committee chaired by Hon. Raphael Wanjala (Budalangi) was told the Coast Water Works Development Agency (CWWDA) that the Agency has failed to reclaim 19 acres of land that was illegally acquired by private proprietors.

Appearing before the Committee, the Acting Chief Executive Officer (CEO) of the Agency Eng. Martin Tsuma told the Members that they are yet to transfer the illegally acquired land back to the Agency's ownership. He however, said the Agency has lodged complaints with the National Land Commission (NLC) and the Ethics and Anti-Corruption Commission to intervene.

"Evictions were not possible since some of the properties had illegal proprietorship with ownership documents," Eng.

Tsuma said.

An inspection tour of three parcels of the land initially owned by the CWWDA in Nyali, Shanzu, and Mikindani areas revealed near total occupancy by private residential premises. This prompted Members to question the Agency's commitment to reclaiming the land.

> "Our people have been here for years, landless and without water supply, but someone sits at an office in Nairobi and illegally allocates land meant for the public to private developers. We need to find a way to hold these illegal sellers of the land accountable and reclaim all the parcels unduly acquired," said Hon. Mohammed Chimba.

> The 21st Report of the Public Investments Committee recommended that the Ministry of Water and Irrigation should engage the NLC with the aim of acquiring ownership documents of the said parcels of land, and for the Coast Water Services Board CEO to seek a court order for the immediate eviction of illegal occupants from its land, and put a caveat on

its properties.

PIC on Governance and Education carries out inspection tour of institutions in Nyanza region

▼he Public Investments Committee on Governance and Education led by Chairperson Hon. Jack Wamboka (Bumula) concluded an inspection tour of learning institutions across the Nyanza Region.

During the tour the Committee visited Jaramogi Oginga Odinga University of Science and Technology (JOOUST) where documents reviewed revealed concerning issues surrounding the construction of a Research Complex at the institution. The project, which commenced in April 2019, came to a halt in October 2020, with the contractor requesting an extension eight months after the contract had already lapsed.

Members identified significant lapses in procurement processes, highlighting numerous instances of legal breaches. They were particularly concerned with the questionable variations in costs associated with the tuition block and ultra-modern library at JOOUST, with reported total costs of Kshs.650 million and Kshs.739 million respectively.

In addition, Members expressed deep concern over the widespread violation of procurement laws in various institutions. They emphasized the importance of institution heads diligently assessing the suitability of contractors to prevent project delays that disrupt students' educational experiences.

In his remarks, Hon. Wamboka said, "This Committee will ensure that students have access to facilities that support their learning within specified time frames. We will put an end to the unacceptable behavior

Committee on Implementation inspects the land owned by Coast Water Works Development Agency

embers of the Departmental Committee on Lands have questioned the performance of the National Land Commission (NLC) amidst the Commission's rejection of proposals in the Land Laws Amendment Bill.

The Committee, chaired by Hon. Joash Nyamoko met with the NLC officials led by Commission Chairperson, Mr. Gershom Otachi, Vice Chairperson, Mrs. Getrude Nguku, Commissioner, Mr. Reginald Okumu and Chief Executive Officer (CEO), Mrs. Kabale Tache in consideration of the Land Laws Amendment Bill, 2023.

In their submissions, NLC said a number of amendments proposed in the Land Laws Amendment Bill will create conflict of interest between the National Government and county governments.

The Commission also raised concerns over the amendments which propose to transfer several functions including the publication of Gazette Notices of Intention to Acquire, inspection of properties to be acquired, oversight on determination of legal and financial claims by Project Affected Persons and issuance of awards from the Commission to the Ministry of Lands.

"Clause 107 of the Land Laws Amendment Bill should be deleted because the proposed amendment will create a conflict of interest whereby the National Government determines the location of projects, approves the acquisition, determines the value, provides compensation funds and

makes the payment," said Mrs. Nguku.

Members expressed dissatisfaction with NLC's submissions noting that the Commission has supported less than 10 percent of the proposed amendments and have not provided justification or made alternative proposals.

"The impact of the amendments proposed in the Land Laws Amendment Bill is enormous. This Bill should be taken seriously. It is very important for this Committee to understand and take into consideration all dimensions of this legislation by interacting with all stakeholders," noted Hon. Nyamoko.

Public participation threshold pushed a notch higher 'with hearings conducted across the county'

The recently concluded public hearings on the Affordable Housing Bill, 2023 could easily pass as the most comprehensive form of public participation undertaken on a Bill yet, since the promulgation of the 2010 Constitution.

Though several Bills have seen Committees traverse the country in a bid to have the public participation in the legislative process, the Affordable Housing Bill saw the Joint Committee comprising of the Departmental Committees on Finance and National Planning and that on Housing, Urban Planning and Public Works collect views in 19 Counties.

The House through the Departmental Committees on Finance and National Planning and that on Housing, Urban Planning and Public works lined up public meetings across 22 constituencies where they jointly collected views from the public and other stakeholders. The hearings saw the legislators visit Narok, Embu, Kisii, Kirin

Other devolved units where the lawmakers received public opinion on the proposed legislation include Baringo,

Nairobi, Wajir, Nakuru, Nyandarua, Tana River, Kilifi, Nairobi and Mombasa Counties.

In an unprecedented move, the exercise saw the team conduct the very first public hearings in

Faza Island, Lamu East Constituency. This is according to the area MP, Hon. (Capt.) Ruweida Obo.

Hon. Ruweida thanked the Members for giving her constituents their maiden opportunity to contribute towards a proposed legislation.

"Hon. Chair, I am very grateful that this Committee found time to receive the view of Lamu East Constituents for the very first time. No other Parliamentary Committee has been here to undertake such an exercise. I am most delighted because, this Committee will also get an opportunity to experience firsthand, how marginalized my people are", she sai

Responding to Hon. Ruweida's sentiments, the Chairperson of the Departmental Committee on Finance and National Planning, Hon. Kuria Kimani who was leading the team, acknowledged that the exercise had granted the Committee an experiential study of the challenges

that the people of the far-flung constituency face and promised that his Committee would propose an economic stimulus program for such marginalized Constituencies.



Members host Ukrainian delegation, root for strengthened collaboration between the two Parliaments

embers of the National Assembly drawn from four Departmental Committees and a delegation from Ukraine Parliament have rooted for deeper cooperation between the two countries' legislatures.

The Kenyan Delegation led by Hon. Maj. (Rtd) Sheikh Abdullahi (the Vice Chaiperson of the Departmental Committee on Defence, Intelligence and Foreign Relations), welcomed the visiting Ukrainian delegation and expressed his appreciation for their visit.

Leading the Ukrainian delegation, Hon. Lesia Vasylenko started by thanking the Kenyan Government for the support they have accorded Ukraine. She further said that Ukraine has a lot to offer to Kenya urging for enhanced collaboration.

"We have more to offer than just grains. We have the know-how on technology and agriculture. Despite the war, we are still able to produce and export food," Hon. Lesia said.

During the meeting, the two delegations deliberated on how to accelerate collaboration in areas of agriculture, trade, security, climate

education and the utilization of drone technology to catalyze economic growth.

Members were particularly interested in the county's drone technology. Both delegations explored avenues for cooperation in utilizing drones to revolutionize their economies. The discussions encompassed the application of drone technology in agriculture, surveillance, and disaster management, with a shared vision of harnessing innovation for economic advancement.

Kenya and Ukraine established bilateral relations in 1993 when Kenya recognized Ukraine as an Independent Country. The Two countries have since established good relations with the establishment of the Ukraine Embassy in Kenya in 2004, and a Consulate of Kenya in Kyiv, Ukraine.

According to the Kenya Institute for Public Policy Research and Analysis (KiPPRA), at the beginning of 2022, Ukraine was the biggest exporter of sunflower oil and the fourth-largest exporter of corn. Kenya's exports to Ukraine mainly consist of tea, coffee, cut flowers and vegetables.

House commences debate on Affordable Housing Bill

ebate on the Affordable Housing Bill, No.75 of 2023, commenced in the National Assembly on Thursday, February 15, 2024 afternoon sitting.

Leader of the Majority Party, Hon. Kimani Ichung'wah, Kikuyu commended Members of the Joint Committee comprising of the Departmental Committees on Finance and National Planning and that on Housing, Urban Planning and Public Works. The Committee did an extensive job on public hearings and collection of expert opinions in 19 out of the 47 counties in the country.

According to Hon. Ichung'wah, the Affordable Housing Program is an opportunity to spur the economy and create employment for youths. He urged members who are yet to identify sites for construction of the houses in their constituencies to do so.

"The Joint Departmental Committees on Finance and National Planning and that of Housing, Urban Planning & Public Works have done a commendable job in conducting public participation across the country. Therefore, I would like to urge Members who are yet to comply with the letter from the Housing Principal Secretary, to do so and propose sites for construction of affordable houses in their constituencies," Hon. Ichungw'ah said.

Chairperson Departmental Committee on Housing, Urban Planning and Public Works, Hon. Johana Ng'eno (Emurua Dikirr), told the House that during the public participation exercise the pertinent questions raised were; how the houses will be accessed impartially, how to make voluntary contribution and how to ensure everyone is levied without discrimination.

Hon. Ng'eno said that, it is through the Affordable Housing

Program that the Government will be able to actualize Article 43 (1) b of the Constitution on right to accessible and adequate housing.

Contributing to the debate, Leader of the Minority Party, Hon. Opiyo Wandayi opposed the Bill arguing that even if the it was to be passed into law, it was not going to contribute to the realization of the rights under Article 43 (1) b of the Constitution.

"The Bill is simply trying to respond to queries raised by the High Court last year. My submission, however is that this Bill does not cure


