Section 7 (1) and (2) of the National Cohesion and Integration Act provides that public offices must seek to represent diversity in the employment of staff and that no public institution should have more than one third of staff establishment from one ethnic community.

However, evidence obtained by the Auditor General when inspecting the books of accounts of the 47 counties and their entities, tell a different story.

In the last 10 years of devolution, the office of the Auditor General has consistently flagged out the issue in the reports of every county government.

According to the Office of the Audi-

tor General all the Public Service Boards and the County Assembly Public Service Boards have breached the law on employment and recruitment policies on diversity.

The committee says the diversity policy will force Governors to take bold steps to address the problem and ensures Counties not only comply with the law but become equal opportunity employ-

The problem was more pronounced when the committee considered Auditor General reports for Embu and Bomet County Executives and the County Assemblies of Kisii and Kericho, all of which failed compliance test on diversity in recruitment.

For example, by the end of June 2021, Bomet County Executive had a total of 4,317 employees on permanent and pensionable terms. However, 4, 219, or 98 per cent, were members of the dominant ethnic community in the county.

The situation is not so dissimilar in the County Assembly of Kisii. According to the Auditor General data, the Assembly had 274 employees as at June 2021. The data indicates that 267 employees, or 97 per cent, comprised members of the ethnic community that is dominant in the county

The County Assembly of Kericho had 100 employees out of which 95 employees, or 95 per cent, were from the dominant ethnic group. In the same year, The Assembly recruited an additional 18 employees, all of which are from the dominant group in the county.

The situation is replicated in all the 47 County Executives and County Assemblies

In the Diversity Policy the Committee is proposing, members want every County Government to express intent on how it will comply with the constitutional provisions and the law on diversity to ensure the country does not slide in ethnic disharmony.

The committee further proposes that the 47 County Public Service Boards should explore ways of inter county transfer for certain cadre of staff for non-local staff as one way of achieving diversity.

The Committee wants the Council of Governors to deliberate the issue and take action on the way forward.

The Committee is proposing that the

law be amended so that in future, the Auditor General must demand for evidence of an employment equity plan in each county before carrying out the auditing process.

"Through the Policy the County Governments should explain how they hope to realise diversity progressively," said Senator Kajwang'.

Governor Barchok told the committee that while he supports the proposal on the policy, employment in counties is hostage of politics.

"There is a lot of politics. We face a lot of resistance from the local community," he said, adding that the process has been undermined by the failure by non-locals to apply for advertised jobs.

Senator Okiya Omtatah said every county that issues an advert for jobs must indicate the quota set aside for non-locals and encourage them to apply.

Senator Edwin Sifuna expressed doubt that the counties will develop the diversity policy. "I don't think any County has an intention to implement an employment equity plan," he said.

"We should impose criminal culpability for those who refuse to implement the plan."

Amend laws to facilitate road safety, Senator Asige tells the House

enator Crystal Asige wants the House to amend for crucial laws that are crucial in fortifying roads and ensure the safety of road users.

The Senator identified amendments to four Acts of Parliament which he urged members to support. They are National Construction Authority (Amendment) Bill; the Traffic (Amendment) Bill; the National Transport and Safety Authority (Amendment) Bill; and the Kenya Roads (Amendment) Bill.

"I am compelled to action, sponsoring amendments to road related legislation. I implore the support of this House in passing these Bills when they come to the Floor, as it is crucial to fortify our roads and ensure the safety of our fellow citizens," said the Senator on Thursday last week.

The Senator made the comments when she issued a statement on the floor to commemoratee the World Day of Remembrance for road traffic victims observed on the third Sunday of November annually.

The day marks a solemn acknowledge-

ment of the toll that road crashes exert on humanity.

Insights gathered from the United Nations Global Road Safety Week held in May this year, illustrate the staggering reality of 1.35 million lives lost annually due to road crashes.

Senator said statics are haunting, especially considering that the majority of these tragic losses affect individuals who are between five and 29 years old.

A report by the Ministry of Roads and Transport indicates that over the past six years, 20,907 precious lives have been lost due to road crashes.

An additional 3,760 were lost as of October 15, 2023, with the highest number of crashes being attribute to motorcycle users at 1,213 deaths.

The National Transport and Safety Authority (NTSA) reports that 80 per cent of road crashes are caused by human error.

The Senator urged the Cabinet Secretary for Roads and Transport Kipchumba Murkomen, through both Houses of Parliament, to put pressure on NTSA,

Kenya National Highways Authority (KeNHA), Kenya Urban Roads Authority (KURA), Kenya Rural Roads Authority (KeRRA) and Kenya Roads Board (KRB) to stop cutting corners when building roads infrastructure.

"The United Nations (UN) notes that the burden of road traffic fatalities weighs disproportionately on vulnerable road users such as pedestrians, cyclists and motorcyclists," Senator Asige told the House.

She pointed out that despite concerted efforts to meet the 2013 UN Sustainable Development Goals (SDGs) of reducing road traffic deaths by 50 per cent, progress remains far from adequate.

"The trend in Kenya has been increasing rather than decreasing from 2,919 deaths in 2017 to 4,619 in 2022. In 2022 alone, Kenya had over 21,000 road accidents.

She said a responsive legal system which must include well thought policy and legislative frameworks, encompassing road design and comprehensive road safety education for drivers and pedes-

rians.

"Safety by design plays a pivotal role in promoting road safety, serving as a fundamental factor in preventing accidents and minimising their severity. Additionally, the consideration of Non-Motorized Transport (NMT) infrastructure that accommodates various road users including road users including pedestrians and cyclists, is crucial. Properly designed sidewalks, bicycle lanes and designated crossings enhance their safety reducing the risk of crashes."

peaker Amason Kingi has urged leaders involved in the National Dialogue process to put the interests of Kenyans first as they seek solutions to the problems facing the country.

The Speaker said that emotional exchanges and grandstanding among the leaders from across the political divide is uncalled for and would only delay realisation of the expectation of Kenyans.

"We are all living in this country. We all know the problems we are going through did not start today," he said, when he presided over a fundraiser in aid of Joy Fellowship for completion of a church building project in Mnarani, Kilifi town, Sunday, November 19.

"To get solutions, we must put aside politics and talk openly. My plea to Kenya Kwanza and Azimio leaders is to put Kenyans first and then those of your political formation."

The Speaker was accompanied by Kilifi Governor Gideon Mungaro, Minority Leader Stewart Madzayo and Senators Okongo Omogeni (Nyamira) and Edwin Sifuna (Nairobi).

"I am well informed of the positions of both sides of the political divide but the best way out is concurrence on how to solve the problems facing Kenyans. We must explore where the rains started beating us and purpose not to repeat the same."

Citing the cost of living, which has been a thorny issue in the country's political discourse, the Speaker said practical measures would take the country out of the quagmire.

"Let focus on production, getting seeds and fertilisers and planting in order to realise better harvests and eradicate the food scarcity," he reiterated, even as he defended President William Ruto on accusations he was overtaxing Kenyans.

"No government takes pride in causing any suffering for its people. The President's fiscal intervention are well intentioned and time will bear this out."

House gives blast compensation committee more time

enators have resolved to extend the term of the Ad Hoc Committee that is pushing for the Compensation of the victims of the 1998 bomb blast.

The House gave the committee, which is chaired by senator Agnes Kavindu, another 100 days to wind up its investigation into the compensation of victims of the 1998 bomb blast of the America Embassy.

The committee has until February 24, 2024 to table its report in the House.

Senator Mohamed Chute, a member of the committee, who moved the motion on the behalf of chairperson, said the renewal of the Committee's mandate will enable them to finalise their work and table the report on time.

"It has been 25 years and the victims are awaiting compensation. We have done a lot. We met the Prime Cabinet Secretary about three weeks ago. We intend to meet with the American Embassy soon," said senator Chute.

Kenyans suffered a great deal during the bombing in 1998. Several Kenyans died and many were maimed. 25 years down the line, they have not been compensated. It should be known that the suffering Kenyans were going through for that period arose out of a bombing by terrorists, not because they were fighting the Kenyan population or the Kenyan Government."

Senator Danson Mungatana cautioned the members of the Ad Hoc Committee that they should use the 100 days to wind up on their work warning that the House will not give them a further extension should they seek.

"Ad hoc committees are not supposed to stay in perpetuity. They should finalise the job, give us a report and we conclude with the matter. The same people who are waiting for that report are the same people who are going to complain that you are taking long," he said.

Senator Joyce Korir supported the mandate of the Ad Hoc Committee saying that it involves a number of stakeholders in terms of finding out on how best they can address the issue of the

Lands Committee to asses the construction of Changara water Pan in Busia County

The Land, Environment and Natural Resource Committee has decided to conduct a fact finding visit to the World Bank-funded, Changara Water Pan Project in Busia County.

During the visit the committee is expected to engage the community before inviting other stakeholders to understand the challenges the project has faced since inception.

The committee made the decision during the consideration of a petition in which residents of the area are seeking the intervention of the Senate to have the project concluded.

The Changara Water Pan project was funded Sh24.8 Million in June 2019 by the World Bank through the National Government.

The project is being implemented by the County Government of Busia through the Department of Agriculture and Fisheries Development and the project was to benefit more than 5,000 families living in Changara through the clean piped water and irrigation.

Changara Petitioners also informed the Lawmakers that Despite the amount allocated, the project which was to be completed by February 2020 instead has stalled due to massive irregularities.

was denied oversight documents, Bill of Quantities Plan (BQs)-and the Environmental Assessment report.

"The pipes drawing water from the water pan to the beneficiaries' farms are all exposed since they were not laid to the recommended depth and the project was conceived and implemented without public participation," said Mr Bildad Masake, one of the petitioners.

The Petitioners revealed the issues have been raised before the County Government of Busia, the Public Procurement Regulatory Authority, EACC and the World Bank but no solution has been given.

Finance committee tours Kakamega County, engages MCAs on financial autonomy

The Committee on Finance and Budget has challenged the leadership of the County Assembly of Kakamega to construct a decent Assembly Building.

The committee issued the plea after a tour of the Assembly in which they came face to face the deplorable state of the facility.

"MCAs are conducting their legislative business in a building that is in deplorable state," observed Senator Ali Roba, who is the chair of the committee.

The Committee was in Kakamega County in response to a question by area Senator Boni Khalwale.

The Senator wants the House furnished with information on the pending bills of

works done for various road projects in the County.

The tour offered the committee the opportunity to traverse parts of the county. It started off on Navakholo Road, through Sitirire-Malava Road, Eregi Road, ending up on Matungu Road where members inspected projects.

The committee later held a site meeting with the County Executive and the Assembly to deliberate on responses to the issues raised.

In the statement, Senator Khalwale wants a statement on the status of pending bills; the rental fees incurred by the County Government of Kakamega and revenue generation and usage by the County Government.

Governor Fedinard Barasa provided tender documents relating to the road projects, a detailed breakdown of annual rental fees for office and utility spaces incurred by the County, disclosing details of the respective contracts including the names of the landlords.

He also outlined measures put in place by his Government to manage and reduce the rental costs. 'The County government has constructed Sub-County Administrators' offices across the 12 Sub-Counties, thus reducing the expenses on rent," said the Governor, adding that the county has plans to build new headquarters in Kakamega Town to house those Ministries operating from rented premises. The Governor told the Committee that they have projected to collect Sh2.4 billion in the 2023/24 financial year as its own source revenue.

The streams of revenue are Health services user fees, Farm inputs, Liquor licenses, Bus parking fees, Cess on factories, and Single Business permits, among others

The committee also held a meeting with the Speaker of Kakamega County Assembly, Hon. James Namatsi, and the Committee on Finance and Economic Planning of the Assembly.

The meeting discussed the need for County Assemblies to have financial autonomy.

Trade Committee inspects development projects in Busia County

The Committee on Trade, Industrialisation and Tourism was in Busia County over the weekend to inspect matters related to trade, industrialisation and tourism.

During the meeting, it was observed that the County has not explore its full potential in terms of trade.

The visit was led by Senator Esther Okenyuri, who was the leader of the team, Senator Karungo Thangwa and area Senator Okoiti Omtatah.

While it is the gateway to East and Central Africa, the County has nothing much to show for it. Busia is among the 18 counties that have signed the Intergovernmental Partnership Agreement with the Ministry of Investment, Trade and Industry for the implementation of the County Aggregation and Industrialial Parks (CAIPs).

Under the agreement, the National Government will transfer Sh250 million to Busia County Government as conditional Grants while the County Government shall allocate Sh250 million to Nasewa Industrial Park.

The Committee visited the project site which is underway and expected to be completed by February 2024.

Further, the committee learnt that the

County Government in collaboration with the National Government is working towards establishing a Trailer Park within Busia town. The park will be a whole ecosystem accommodating all social amenities and at the same time increase the County's own source revenue

During the visit, the Committee held a meeting with the Governor Paul Otuoma who sought the indulgence of the Senate in the amendment of the Cooperatives Act which contains provisions that are detrimental to counties.

"Cooperatives is a devolved function but their registration is still being done by the National Government," said Governor Otuoma.

The committee also visited the One Stop Border Post (OSPB) where it learnt the daily activities at the Border and the challenges.

The narrow road leading to the OSBP and inadequate verification space at customs yard have been the major causes of traffic jams.

The committee observed that there is need to redesign the OSPB infrastructure and check on the frequent power fluctuations affecting systems and scanner operations.

enator Ali Roba has thanked the delegates from the 12-member states who attended the 27th Ordinary executive committee session of the Forum of Parliaments of Members States of the International Conference on the Great Lakes Region (FP-ICGLR).

While officially closing the session held in Nairobi from November 21 to 24

2023, Senator Roba said the meeting had fruitful discussions and urged the delegates to make the resolutions a reality.

During the meeting, the FP-ICGLR Executive Committee received an update on the preparations for the Joint IC-GLR/FP-ICGLR Electoral Observation Mission to DRC and reviewed the recent developments on the security situation of

the Central African Republic, South Sudan, Sudan and the Democratic Republic of Congo.

The FP-ICGLR is an inter-parliamentary organisation composed of the 12 National Parliaments of the ICGLR Member States, which include Kenya, Uganda, Rwanda, Tanzania, Angola, Burundi, Zambia, South Sudan, Central

African Republic, the Republic of Congo and the Democratic Republic of the Congo.

It aims to make a significant parliamentary contribution to the implementation of the Pact on Security, Stability and Development in the Great Lakes Region.

Senate keen to help County Assemblies to deliver on their mandate, says Deputy Clerk Gichangi

eputy Clerk Eunice Gichangi has said the Senate is keen to ensure that counties deliver on their mandate as provided for in the Constitution.

The Deputy Clerk told members of the Library and Broadcast Committee of the County Assembly of Embu that the Senate's mandate is specific and oversight of devolution as stipulated under Articles 94 and 96 of the Constitution."

"Under this mandate the Senate will ensure that County Governments and their entities deliver on their mandate for the success of devolution," she told the delegation.

The delegation, comprising seven Members and four officers of the Embu County Assembly,was on a weeklong benchmarking tour of Parliament to acquire skills and knowledge on how to run live broadcasts for the assembly's legislative sessions on Radio and Television,

Explain bursary Fund expenditure, watchdog committee directs Bomet Governor Barchok

The Committee on County Public Investments and Special Funds (CPISFC) has directed Bomet Governor Hillary Barchok to submit a detailed report indicating how the County disbursed Sh9.7 million set aside as Bursary fund for the 2019/20 financial

According to the Auditor General, the county allocated Sh9.7 million to the account which was disbursed through the Higher Education Loans Board.

However, the audit indicates that HELB only disbursed Sh7.4 million to beneficiaries, resulting in a remainder of Sh2.2 million within its accounts.

"I instruct you to ensure the Fund administrator provides statements verifying that Sh2.2 million is still with HELB,' the committee directed through Senator Ojienda, who chaired the session.

Senator Ojienda is the vice chair of the committee.

"Additionally, I want you to confirm

that the Fund's legal framework with the County Government of Bomet and HELB adheres to the HELB Act's section 12 and Regulation 197 of the Public Finance Management (County Governments) Regulations, 2015."

decisive action plans designed to bolster the transparency and fiscal prudence of the Fund to bring about substantial improvements in the way the Fund oper-

The Committee also unearthed discrepancies in the financial statements, where the costs of administering the Fund had been inaccurately document-

As a corrective measure, Governor Barchok was instructed to address this inconsistency, ensuring that such charges are correctly listed as expenses in future documentation.

The House concludes debate on the President's State of the Nation address

enators have concluded debate on the Presidential Speech on the State of Nation address with an acknowledgement that high cost of living is hurting a majority of the population.

During the three days debate, a section of lawmakers assured the country that all is not lost and that the national government has good plans to turn around the economy.

Standing Order 27 (5) of the House rules provide that the President's speech may, as soon as practicable, be tabled in the House after it has been delivered.

Part 6 of the rule provides: "A Senator may give a notice of Motion, that "The Thanks of the Senate be recorded for the exposition of public policy contained in the Address of the President" but debate on the Address shall not exceed three sitting days.

Majority Whip Boni Khalwale tabled the address and while moving the motion recounted to the House how elected leaders have been subjected to humiliations due to high cost of living.

"Things are so difficult such that for a man who has never been heckled across the Luhva nation for the first time, I was not only heckled but I was heckled at Malinya Stadium. Malinya Stadium is my home and polling station," said Senator Khalwale told the House.

He advised the lawmakers on the need to work together regardless of political affiliation in finding a solution to the economic woes facing the country.

"I urge colleagues, whether in the opposition or not--- We have been there and now I am in the Government. Let us work together even if we are going to oppose each other in the forthcoming elections. Members of the opposition kindly push us hard enough so that we can deliver," he said.

Senator Danson Mungatana said the government interventions toward the high cost of living have started bearing fruits while citing his county as one of the areas where the Kenya Kwanza administration is rolling out key projects.

"Kenyans usually pay Sh60 billion to import rice from Pakistan and other countries because we don't grow enough rice. Therefore, the President's plan in Tana River has helped to reduce the amount used by the country to buy rice wreaking havoc in various regions. from Pakistan. The rice is now being grown in the Tana River," said senator Mungatana.

Senator Edwin Sifuna said the President erred by saying that the prices of maize flour have come below Sh200 pouring water on the interventions taken by the government like subsidized fertilizer to arrest the high cost of living.

"I have tried to convince this Senate that, in fact, the definition of food security includes a reference to people's preferences. If, for instance, my household has been eating Jogoo Unga and I was buying it at Sh100 and it goes to Sh250, you cannot then try to convince me to start buying another brand that I have never heard of, and I do not know where it comes from because it is retailing at Sh150," said Senator Sifuna.

Senator Ali Roba lamented that the government was only focused on the agricultural sector by underscoring the subsidised fertiliser while forgetting the pastoral sector.

He noted that President Ruto failed to tell the country what his administration is doing to address the El-Nino which is

'The State of Nation Address is supposed to touch on, create and give hope to the population of this country," said the Senator, pointing out that roads have been cut off in the northern region.

"Flooding has affected hundreds of thousands of the population in the region as a whole. The President's Speech fell short of creating hope and discussing the impact that the El Nino phenomenon is causing in our region," said Senator

Majority Leader Aaron Cheruiyot asked his colleagues who are not convinced by the government interventions to arrest high cost of living to provide the alternative instead of criticising the Kenya Kwanza administration.

"If you disagree with the policies being proposed, be it on financial inclusion, taxation or subsidy programmes being run, kindly offer an alternative," he said.

He added: "If you have a better idea, we are willing to listen. We will be convinced by the strength of the argument that you carry not the loudness of your noise."

Government is working as one unit to address effects of el nino, Roads CS tells Senators

oads and Transport CS Kipchumba Murkomen has revealed that all the Ministries are working together to respond to the effects of El nino rains. He said his Ministry is dealing with the infrastructure challenges but there is not so much they can do at the moment regarding construction of the roads since the rains are still ongo-

In a statement to the House, the CS said the Kenya National Highways Authority (KeNHA) has been appointed as the lead emergency response agency to help in opening the roads in the affected areas in the Country. The CS urged the Senators to sensitise Kenyans both motorists and pedestrians to remain vigilant during this rainy season and to stop crossing swollen rivers to avoid loss of

"Essential commodities will be airlifted to the affected areas to ensure that the affected persons do not suffer," he told the lawmakers during Questions Time on Wednesday.

The Cabinet Secretary had appeared before the House to respond to questions by Senators on status of various roads in the Country and the government plan to upgrade Kakamega Airstrip to an international Airport.

"Kakamega Airstrip runway can only be extended up to a maximum of 1,400m. Ultimately, if the future traffic may necessitate bigger aircrafts requiring a longer runway, the airport relocation is to be considered."

Government keen to complete construction of stadia across the country, CS Namwamba tells the House

The government has subjected the stalled construction works for L football stadiums to forensic audit to determine their viability, Sports has told the House.

The CS told the lawmakers during Questions Time on Wednesday the construction works will only resume after the audit and that the State is determined to complete the projects.

"There are a number of stadia that commenced under the previous administration. We have done a quick assessment of those facilities. We have gone further to subject these projects to forensic audit just to determine value for money. That forensic audit is at the tail end," said the CS.

Once the exercise is concluded, said CS Namwamba, the Kenya Kwanza administration will revive the stalled stadiums adding that the government has no plans to abandon the projects.

"As soon as that audit process is concluded, we have every intention to complete every project that has already expended public resources. We don't intend to let these projects go to waste. For standards, I am pleased to inform this House that the Ministry has now developed a Sports and Creatives Infrastructure masterplan."

The CS said the master plan will be used in setting up sporting facilities at various levels.

"The master plan is very clear on Cabinet Secretary Ababu Namwamba what kind of a facility to do at the International level, regional and community levels. That masterplan will guide all future Sports' facilities in the country," he

> Apart from Moi International Sports Centre, Kasarani, and Nyayo National Stadium, a majority of sporting facilities outside the capital are in a sorry state.

> Stadiums such as Kipchoge Keino in Eldoret (Uasin Gishu County) and Wilson Kiprugut Chumo Green Stadium (Kericho County) have been named after big sports names but remain an eyesore. Other stadiums are Wote, Marsabit, Mombasa and Kisumu among others.

> CS Namwamba insisted that the government is committed to complete the nine stadiums which were announced in 2016 when President William Ruto served as deputy president.

> "We have visited all the nine stadia and we have made an assessment of what need to be done and I am assuring this House that the completion of these nine stadia is a top priority for the Ministry and this administration," he said.

The clocktower, which symbolises the august House, shares a close semblance with the Big Ben's Clock Tower in London and the Tower of the Palace of Westminster in London only that Kenya's is a miniature version.

Amysa Connel, the architect behind the design of the clocktower, and the Parliament Buildings, must have drawn inspiration from the Gothic architectural design characteristic of most Parliaments constructed at the height of the British Empire in the 19th Century.

Featuring a bell and clock, the clocktower was a gem of its time. The ringing of the bell and chiming of the cloak were used to guide time both in Parliament and Nairobi City in general.

Those were the days long before wrist watches and house clocks, that we are accustomed to in modern times, were discovered.

Over time, the clocktower has been reduced to an antique piece of aesthetic work, a stark contrast from the days of yore when it was central to the lives of residents in the cities of UK.

Locally, the clock tower shares a

survived the test of time and stand out close semblance to the clocktower sitting atop Nairobi City County Government building a few meters away.
