THE JUDICIAL SERVICE (TRIBUNAL TO INQUIRE INTO THE CONDUCT OF JUSTICE MOHAMMED NOOR KULLOW) RULES OF PROCEDURE, 2024

It is notified that the Tribunal appointed by **His Excellency the President** *vide* Kenya Gazette Notice No. 2536 of 2024, to inquire into the Conduct of Justice Mohammed Noor Kullow has, in exercise of powers conferred under **section 31 (5) of the Judicial Service Act**, formulated its rules of procedures.

The Tribunal was appointed by **His Excellency the President** pursuant to the recommendations of the Judicial Service Commission on the removal from office of Justice Mohammed Noor Kullow on the ground of gross misconduct and breach of the Judicial Service Code of Conduct for Judges. The mandate of the Tribunal is to:

"consider the Petition for the removal of the Hon. Justice Mohammed Noor Kullow from office that was submitted by the Judicial Service Commission and to inquire into the allegations therein."

In that regard, the rules of procedure referenced as '**The Judicial Service (Tribunal to Inquire into The Conduct of Justice Mohammed Noor Kullow) Rules of Procedure, 2024**' have been published by the Kenya Gazette as **Notice No. 4660 of 2024**.

Accordingly, and in discharge of the statutory obligations arising to all regulation-making authorities pursuant to **Section 11 (2) of the Statutory Instruments Act**


(Cap.2A), kindly be pleased to receive a copy of the rules of procedure for consideration by the National Assembly.
