The Parliamentary Network on the World Bank and the International Monetary Fund (IMF) is an independent, non-governmental organization that provides a platform for Parliamentarians from across the world to engage with the World Bank Group and the IMF on issues of transparency, accountability, and development effectiveness. The Network facilitates dialogue between legislators, civil society, and international financial institutions, with a focus on promoting good governance in the management of public resources, advancing poverty reduction strategies, and supporting policies that foster inclusive economic growth.

Honourable Senators,

I wish to inform the Senate that Sen. Maureen Tabitha Mutinda, MP, has been elected to serve as a Member of the Board of Governance of the Parliamentary Network on the World Bank and the IMF, for the term 2025 – 2027. The Board of Governance is charged with the responsibility of setting the strategic

ii) Distinguished dignitaries and reputable sons and daughters of Busia County on the auspicious occasion of the Sittings of the Senate in Busia County - Wednesday, 8th October, 2025

"Honourable Senators, Ladies and Gentlemen,

I take this opportunity to acknowledge the presence, in the Speaker's Gallery this afternoon, of Hon. Kenneth Marende, EGH. As Honourable Senators are aware, Hon. Marende is a renowned personality in the Western Kenya region who comes from Vihiga County. He served as the Speaker of the National Assembly in the 11th Parliament from 2008 to 2013. He also served as the Chairperson of the Parliamentary Service Commission (PSC). Prior to being elected Speaker of the National Assembly, Hon. Marende served as Member of Parliament representing Emuhaya Constituency between 2003 to 2007.

A major hallmark of Hon. Marende's tenure as Speaker, was the opening up of Parliament to the public through live broadcasting of parliamentary proceedings; modernization of the National Assembly Chamber and expansion of parliamentary facilities for Members and staff; and the establishment of structures to accommodate a bicameral Legislature, following the promulgation of a new Constitution in August, 2010.

- A renowned jurist, long-serving Attorney General of the Republic of Kenya and the first Senator for Busia County.
- 3. Hon. (Prof.) Julia Ojiambo
- A renowned politician and academic. First female Assistant Minister appointed to various portfolios. Party Leader of the Labour Party of Kenya, Member of Parliament for Busia Central Constituency, now known as Funyula Constituency, a crusader for affirmative action and one of the founder members of the Maendeleo ya Wanawake.
- 4. Hon. Justice (Dr.) Smokin Wanjala, CBS
- Renowned legal scholar, Judge of the Supreme Court of Kenya and current Director of the Kenya Judiciary Academy.
- 5. Hon. Sospeter Ojaamong, MGH
- First Governor of Busia County and former Member of Parliament representing Amagoro Constituency.

6. QUESTIONS AND STATEMENTS

a) Statements pursuant to Standing Order 52(1)

i) The Senator for Nairobi City County (Sen. Edwin Sifuna, MP) on behalf of Nominated Senator (Sen. Crystal Asige, MP) made a Statement on the commemoration of Dyslexia Awareness Month.

Thereupon, the Senator drew the attention of the House to the global commemoration of Dyslexia Awareness Month, observed every October as part of the international neurodiversity movement. She highlighted the historical development of dyslexia research, tracing its identification in the late 19th century, and underscored the contributions of institutions such as the International Dyslexia Association in promoting inclusivity for persons with learning differences. The Senator emphasized that the commemoration presents an opportunity not only to raise awareness and promote accessibility but also to celebrate the creativity and resilience of persons living with dyslexia.

The Senator noted that in Kenya, dyslexia and other hidden learning disabilities remain poorly understood and inadequately addressed within the education system. Citing statistics from the Dyslexia Organisation of Kenya, she observed that 60% of children in Grades 5 to 8 cannot read at grade level, with up to 20% struggling with undiagnosed learning difficulties. He lamented the stigma and misconceptions surrounding invisible disabilities such as dyslexia and schizophrenia, which are often dismissed as weakness or madness, resulting in exclusion and rights violations. He stressed that these challenges constitute a breach of constitutional rights to education, equality, and non-discrimination under Articles 43(1)(f) and 27.

The Senator urged that Kenya transitions towards a dyslexia-friendly and disability-inclusive education system, aligned with international best

practices. The Senator pointed to the Learners with Disabilities Bill (Senate Bills No. 4 of 2023) as a comprehensive framework to ensure equal access, eliminate discrimination, and cover hidden learning difficulties such as dyslexia. He appealed to the House to pass the Bill without delay, translating awareness into action, and encouraged Senators to support the activities of the Dyslexia Organisation of Kenya, specifically the upcoming NeuroInclusion Gala Dinner and Tree Planting Hike, as a demonstration of solidarity with persons living with dyslexia and other invisible disabilities.

ii) The Senator for Mombasa County (Sen. Mohamed Faki, MP) made a Statement on the ongoing strike by academic staff in public universities.

Thereupon, the Senator noted that the industrial action by members of the University Academic Staff Union (UASU) had significantly disrupted learning in affected institutions. He recounted a recent visit to Maseno University alongside Sen. Issa Boy, where they witnessed lecturers demonstrating, dressed in 'deras', to demand payment of salary increment arrears amounting to Ksh. 7.9 billion. The Senator observed that the strike had brought academic activities to a standstill, leaving students stranded despite having paid tuition fees.

The Senator urged the Government and UASU to engage in constructive dialogue to find a pragmatic solution, emphasizing that while the Government may not be able to pay the full amount at once, it should negotiate a feasible payment plan. He stressed that the prolonged impasse risks disorganising academic programs and undermining the quality of higher education in the country. To this end, he called upon the Standing Committee on Labour and Social Welfare and the Standing Committee on Education to jointly intervene and facilitate an urgent resolution to the crisis, in order to safeguard both the welfare of academic staff and the learning continuity of students.

The Senator commended Maseno University's management for its steady growth in student enrolment and contribution to local economic development, noting that the institution's progress reflects the positive impact of devolution on regional education and service delivery.

iii) Nominated Senator (Sen. Hezena Lemaletian, MP) on behalf of Nominated Senator (Sen. Veronica Maina, MP) made a Statement on the rising cases of early teenage pregnancy and sexual and gender-based violence (SGBV) in Busia County.

Thereupon, the Senator cited data from the National Syndemic Disease Control Council, where she noted that between 2016 and 2024, more than 65,000 teenage pregnancies were recorded in the county, with 4,542 cases reported in 2024 alone, Samia Sub-County recording the highest rate in the country. The Senator noted that early pregnancy robs young girls of education and economic opportunity, exposes them to

serious health risks such as maternal complications and HIV infections, and perpetuates cycles of poverty and social exclusion.

The Senator also highlighted that SGBV remains a growing crisis, with 2,884 cases reported among adolescents in Busia County between 2016 and 2024, a sharp increase over the years. She observed that enforcement of existing laws, including the Sexual Offences Act and the Children Act, has been slow and inconsistent despite stringent penalties for offenders. The Senator urged the Judiciary and law enforcement agencies to act more decisively to ensure justice for victims and deter perpetrators. She also called on the Government to support victims through compensation, psychosocial care, and reintegration into the education system, while ensuring that children born to teenage mothers receive access to healthcare and education.

The Senator further announced that the Kenya Women Senators Association (KEWOSA) would champion new legislation to strengthen protection for victims of SGBV. The proposed law would provide for safe shelters, restitution from offenders, improved evidence handling, cross-border repatriation of offenders, use of video testimonies, and the outlawing of informal "kangaroo courts." She urged collective action through stronger law enforcement, community awareness and national advocacy to end the scourge of teenage pregnancy and sexual violence, reaffirming KEWOSA's commitment to lead this fight across the country.
