There being no Quorum present at the commencement of the House; the Speaker ordered the Quorum Bell to be rung for ten minutes;

And Quorum having been attained within the ten minutes, business commenced.

5. **COMMUNICATION FROM THE CHAIR**

The Speaker issued the following Communication—

**Appointment of Senators to Mediation Committees on Three (3) Bills**

“Honourable Members,

You will recall that on Wednesday, 15<sup>th</sup> April 2026 and on 2<sup>nd</sup> June 2026, I notified the House of the referral of the **National Construction Authority (Amendment) Bill (National Assembly Bill No. 59 of 2022)**, the **Fire and Rescue Services Professionals Bill (Senate Bill No. 55 of 2023)** and the **Division of Revenue Bill (National Assembly Bill No. 2 of 2026)** to mediation committees.

You may further recall that I also informed the House of the appointment of Members to represent the National Assembly in the respective Mediation Committees on the three Bills and guided that they await the appointment of Senators for the respective Committees to be fully constituted.

**Honourable Members**, I have since received correspondence from the Senate notifying that the Speaker of the Senate has appointed Senators to the Mediation Committees to consider the three Bills as follows—

**Honourable Members**, with the appointment of Senators, the Mediation Committees on the three Bills are now fully constituted in terms of Article 113 of the Constitution. In this regard, I call upon the appointed Members of this House to reach out to their Senate counterparts with a view to expeditiously commencing the mediation process on the respective Bills.

The Mediation Committee on the Division of Revenue Bill, 2026 is particularly encouraged to undertake the mediation process in earnest, noting the centrality of the Bill in unlocking subsequent budget processes and the attendant timelines.

The House is accordingly informed.

## **6. PETITIONS**

The Speaker conveyed the following Petition—

**Regarding amalgamation the civil service non-contributory pension schemes superannuation fund**

**"Honourable Members**, Article 119 of the Constitution of Kenya, 2010 accords every person the right to petition Parliament to consider any matter within its authority. Further, Standing Order 225(2)(b) requires the Speaker to report to the House any Petition other than that presented by a Member.

In this regard, Honourable Members, I wish to report to the House that my office has received a Petition from **Mr. John Serem, Eng. Richard Bett** and **Ms. Olive Chepkoech**, on behalf of **the Kenya National Association of Public Service Pensioners (Kericho Branch)**. The Association represents former civil servants and retirees across the Republic.

The Petitioners aver that the enactment of the **Public Service Superannuation Scheme Act, 2012**, facilitated the transition from the traditional Non-Contributory Defined Benefit (DB) system to the current Defined Contributory (DC) scheme, effective 1<sup>st</sup> January 2021.

The Petitioners contend that this transition has created a discriminatory dual-pension architecture. They argue that while new entrants benefit from the modern contributory framework, existing retirees remain tethered to an obsolete system characterised by inadequate and irregular payments. This disparity, they claim, constitutes unconstitutional discrimination against persons of the same class of entitlement.

**Honourable Members**, the Petitioners further cite **Section 5 of the Pensions Act (Cap. 189)**, which defines a pension as an absolute right earned through service. They express grievance over the statutory requirement for retiring officers to commute one-quarter ( $\frac{1}{4}$ ) of their pension, asserting that this practice significantly diminishes the monthly disposable income available to retirees.

**Honourable Members**, the Petitioners further recall that in 2014, the **Salaries and Remuneration Commission (SRC)**, guided by actuarial valuations, recommended a periodic review of pension benefits every three years to safeguard against inflation. They allege that the National Treasury has failed to undertake these comprehensive reviews, leaving pensioners exposed to economic hardships occasioned by the rising cost of living.

**Honourable Members**, the Petitioners are also concerned with the inconsistent application of **Section 17 of the Pension Act**, which governs the payment of benefits to dependants. They claim that the administrative process for next-of-kin to access benefits upon the death of a principal officer remain unnecessarily onerous and prohibitive.

**Honourable Members**, the Petitioners are concerned that the Government has inconsistently applied provisions of Section 17 of the Pensions Act that obligates payment of pension benefits to dependants upon the death of an officer. In this regard, access to Pension Benefits upon death of the Principal Officer by the respective next of kin remains administratively onerous hence violating the said provision.

The Petitioners confirm that the matters raised herein are not pending before any court of law or any other constitutional or legal body.

In view of the foregoing, the Petitioners therefore pray that the National Assembly:

- (a) Directs the amalgamation of all non-contributory civil service pension schemes into a single, unified, and sustainable framework;
- (b) Urges the National Treasury and SRC to conduct an immediate actuarial study and gazette pension increases to mitigate the effects of inflation; and
- (c) Facilitates the review of the **Pensions Act (Cap. 189)** and **Pension (Increase) Act (Cap 190)**.

**Honourable Members**, having determined that the matters raised are within the authority of this House, I hereby commit this Petition to the **Public Petitions Committee** for consideration, pursuant to **Standing Order 227(1)**.

The Committee is required to consider the Petition and report its findings to the House and the Petitioners in accordance with Standing Order 227(2).
